- All cabin, galley and hold waste on the aircraft must be collected, transported, stored and/or treated by a department approved service provider or as directed by a Biosecurity Officer.
- Note: In the absence of an approved service provider or a direction from a biosecurity officer, waste must not be discharged from the aircraft.
- Present all items of food or products of animal or plant origin to a Biosecurity Officer for inspection on arrival.
- Undertake pratique reporting and aircraft disinsection requirements.
- Meet all applicable department costs. (Biosecurity (Cost Recovery) Regulation 2016)

- No waste, stores or other goods (including baggage) are to be removed from or loaded onto the aircraft.
- No passengers are permitted to disembark or embark the aircraft.
- Only crew members directly engaged in refuelling or servicing of the aircraft are permitted to disembark and must return to the aircraft immediately on completion of their function.
- Meet all applicable department costs (Biosecurity (Cost Recovery) Regulation 2016).
