

Background

Enduring partnership

 DAFF is committed to working closely with state and territory governments, peak bodies and industry to support the growth and sustainable development of Australia's aquaculture industry. This includes:

- working with the Tasmanian Government and Blue Economy CRC to allow a trial of aquaculture in Commonwealth Waters off the Tasmanian Coast;
- collaborating with state and territory governments and industry to review the 2017
 National Aquaculture Strategy.

Status of the Macquarie Harbour Oxygenation Program (MHOP)?

- This project is funded through FRDC. We have received briefings from FRDC and have observed meetings of the project's technical meeting.
 - Project is continuing on the expected timeline, moving up to the maximum amount of dissolved oxygen for the current system of ~ 4.5 tonnes per day. No adverse environmental responses have been detected.
 - o Trials conclude in June with final reporting in October.
- DCCEEW is working through implementation of the Australian Government commitment of an additional \$21 million to support Macquarie Harbour oxygenation and habitat restoration.



- My understanding is that no decision on the reconsideration of the 2012 referral decision has been made and marine farming is not required to stop during the reconsideration process.

Are the recently announced conservation measures a sign that salmon farming can continue in Macquarie Harbour?

- No. These announcements do not have any bearing on the Minister for the Environment and Water's reconsideration decision.
- These measures will benefit the local ecosystem and the Maugean Skate population irrespective of the outcome of the reconsideration decision.

Hi SJ,

My brief notes from Matt Lowe and our meeting with s. 47F(1) from Salmon Tasmania:

- s. 47F(1) will be meeting with Minister Plibersek and Minister Collins.
- *****sees more alignment between aquaculture and agriculture than aquaculture and wild capture fisheries.
- Matt Lowe noted DAFF's and Minister for Agriculture Fisheries and Forestry's role as fisheries minister. Not the regulator or decision maker under the EPCB Act.
- Salmon Tasmania agreed that in 2016 Macquarie Harbour was stressed: 2016 dry summer; hydro dams got driven hard; peak salmon production.
- Production was then regulated down to 9000t (equivalent) which Salmon Tasmania see as sustainable levels for the environment and commercially. MH has recovered since 2016 under state regulation and NCA-PM.
- Salmon Tasmania consider that it is not clear what caused the demise of the skate cant definitively answer and Maugean skate population sampling is not complete.
- Salmon Tasmania see the 'bedlam' outcome as a Controlled Action decision under the EPBC Act –
 under which aquaculture becomes illegal. Lawyers looking at injunctions but ST consider a CA
 decision would see:
 - o retailers under pressure
 - o loss of social licence
 - loss of 1.5 million fish
 - o economic and social impact
 - PR / perception of industry majority of people neither strongly for or against aquaculture but a CA decision would work strongly against industry.
 - o s. 47(1)(b)

- Implications for Tasmanian regulation of salmon noting that the industry complies with Tas regulation.
- Salmon Tasmania see an update to 2012 decision NCA-PM as being able to apply new state government conditions with oxygen as the key determining factor.
- s. 47(1)(b)
 - The Oxygenation project runs out in 12 months (October next year). Questions around ongoing funding. Noted it would take 6-12 months to get new technology into Australia and scale up.

- Salmon Tasmania question whether there is a science based justification for reduction.
 - As opposed to tight adaptive management.

• On land not a viable option given cost (>\$160 million? to pick up 25% production on land but would still need to have marine grow out stage). Not commercial on west coast - you could find suitable land - but power, treatment system, release of waste water.

Looking to the future, ML noted review of the National Aquaculture Strategy which *-47F(1) noted could consider issues such as

- Social licence
- Focus on aquaculture generally not just salmon
- The role of the Blue Economy CRC.
