

## Application for plant export accreditation of packhouses

#### Section A: General information

#### Purpose of this form

For managers of packhouses to apply for accreditation to export the following to protocol markets:

- avocados
- bananas
- capsicums
- carrots
- · citrus (to New Zealand only, if not accredited for other markets)
- cucurbits (butternut, cucumber, honeydew melon, pumpkin, rock melon, scallopini, squash, watermelon and zucchini)
- kiwifruit
- lychees
- papaya
- persimmons
- potatoes
- strawberries
- sweetcorn.

For information about applying for accreditation to export other commodities, contact the relevant peak industry body listed in the <u>industry advice notice</u> issued before the export season begins.

#### **Before applying**

Understand your obligations under:

- the Export Control Act 2020 and Export Control (Plants and Plant Products) Rules 2021
- Guideline: Management of horticulture export accredited properties
- Guideline: Audit of horticulture export accredited properties.

Ensure the commodity you need accreditation for is listed in <u>Reference: Table of plant export</u> protocol markets.
