

## Lineage of the development of the *Australia's Indigenous forest estate (2020)* dataset

*Australia's Indigenous forest estate (2020)* is a continental spatial dataset of land and forest over which Indigenous peoples and communities have ownership, management or co-management, or other special rights.

Dillon et al. (2015) described the creation of four category combinations that together captured the range of relationships between Indigenous peoples and land or forest; and were used for reporting in *Australia's State of the Forests Report 2013* and *Australia's State of the Forests Report 2018* (MIG and NFISC 2013, 2018). However, individual attributes of ownership, management or co-management and other special rights, were conflated across multiple categories and could not be independently and separately identified.

Jacobsen et al. (2020) disentangled the above Indigenous estate categories, and described a process for reporting separately on each of the individual attributes of Indigenous ownership, Indigenous management or co-management, and other special rights for Indigenous peoples and communities.

The method and data in this data package uses the same sources of data used for assembling the *Australia's Indigenous forest estate (2018)*<sup>1</sup> spatial dataset, but represents the information on the Indigenous land estate by the above separate attributes in accordance with the new methodology of Jacobsen et al. (2020). The Indigenous land dataset is combined (intersected) with forest cover information from the *Forests of Australia (2018)*<sup>2</sup> dataset. The resulting output dataset provides information on the Indigenous estate over forest and non-forest land.

The Indigenous estate land attributes are as follows (ABARES 2020; Jacobsen et al. 2020):

**Indigenous owned:** Freehold land or forest that is owned by Indigenous communities, or land and forest for which ownership is vested through other mechanisms.

**Indigenous managed:** Land or forest that is managed by Indigenous communities.

**Indigenous co-managed:** Land or forest that has formal, legally binding agreements in place to include input from Indigenous people in the process of developing and implementing a management plan.

**Other special rights:** Land or forest subject to native title determinations, registered Indigenous Land Use Agreements and legislated special cultural use provisions.

This dataset was developed from multiple data sources, including national, state and territory datasets related to land in which there is an Indigenous interest. Table 1 describes each of the data sources used and the source agency, with allocated Indigenous land attributes. Further information on each of the data sources used, currency and attributes of value is included in the appendix.

All input datasets were converted to 100 metre cell size rasters in Esri grid format in Albers projection, aligning with relevant standard NFI state or territory masks (also known as NFI snap grids). Where the input dataset was in polygon format, the **Polygon to Raster** tool was used to convert the polygon dataset to raster format, using the **Maximum Combined Area** option.

The output national Indigenous land dataset was then combined (intersected) with the forest cover information identified by the Multiple Lines of Evidence (MLE) approach used to develop the *Forests of Australia (2018)*<sup>3</sup> dataset. This identified the forest cover status of land over which Indigenous people have ownership, management or co-management, or rights of use.

The final output dataset comprises a single raster accompanied by multiple layer files that display the following attributes:

- the land and forest that in Indigenous owned
- the land and forest that in Indigenous managed or co-managed
- the land and forest that is subject to other special rights for Indigenous peoples and communities
- the Indigenous land estate
- the Indigenous forest estate

## Appendix

Further details of all datasets listed in Table 1 are provided herein. This includes the dataset name, data custodian, currency and the attribute field(s) of value used for the analysis to assemble the *Australia's Indigenous forest estate (2020)* spatial dataset. The currency of all datasets is 2016 unless otherwise stated. All data was sourced by the National Forest Inventory for preparation of *Australia's State of the Forests Report 2018* (SOFR 2018), and were filtered to exclude data/records after the SOFR 2018 reporting period end date of 30 June 2016 where possible. Datasets are ordered in the same manner as in Table 1.
