### Overview

This issue of the *Australian forest and wood products statistics* (AFWPS) includes 2020-21 data for key domestic indicators of forestry sector activity such as new housing commencements and the trade of wood products. It also reports 2019-20 data on the value and volume of logs harvested and Australia's commercial plantation estate. The report is supported by summary tables in excel format that may be accessed below in the Download section. This AFWPS also has a Power BI data visualisation that provides users with an interactive dashboard to interrogate the data.




Figure 2 Minimal new plantations have been established in recent years






Figure 3 Logs harvested from hardwood plantations declined in 2019-20, with production value falling further than production volume.

Figure 5 Total logs harvested from native forests and native forest log production value decline in 2019-20






Figure 6 Total new houses commenced increased by 36% in 2020-21




