- not been issued a tariff rate quota certificate for a consignment of the quota type for export in either of the 2 quota years preceding the current quota year, using new entrant access quota.

I also declare that I am not an associated entity, as defined under the Corporations Act 2001, of any person who has been:

- allocated a tariff rate quota entitlement under section 30 of the Rules for the quota type specified in this form and the current quota year or any of the 3 years preceding the current quota year (see s28(2)(d)(i) of the Rules)
- issued a tariff rate quota certificate for a consignment of the quota type specified in this form, for export in the current quota year or either of the 2 quota years preceding the current quota year, using new entrant access quota (see s28(2)(d)(ii) of the Rules).
