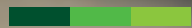

Welcome to the first Annual Report of EPSA

Electronic Product Stewardship Australasia (EPSA) was approved as a co-regulatory arrangement under the Australian Government's Product Stewardship Act on 4 April 2013, and so this Annual Report reflects our achievements in our first year of operation.

EPSA is wholly owned by Sims E-Recycling Pty Ltd, trading as Sims Recycling Solutions (SRS). Sims has a long history in Australia, having been established in Sydney in 1917, and Sims Recycling Solutions (SRS) was created in 2002 to address the explosive growth in global electronic waste. The company now spans over 50 multi-service processing facilities on five continents, and worked closely with the then Federal Department of the Environment, Water, Heritage and the Arts to help develop the Product Stewardship (Televisions and Computers) Regulations.

We are delighted to report that EPSA's achievements in its first year of operation show that it is effectively:

- harnessing the experience and reach of SRS and providing a recycling industry based solution to Australian TV and computer waste;
- delivering on the outcomes required by the Product Stewardship Act 2011 and the National Television and Computer Recycling Scheme using best possible practices;
- leveraging existing relationships with manufacturers and collection points;

- establishing new relationships with members and key stakeholders who need a reliable partner to comply with Corporate Social Responsibility (CSR) obligations and protection of their brand; and
- providing reliable, wholly compliant services to customers who demand a positive environmental outcome.

With the first year behind us and the valuable experiences taken on board, we look forward to next year and the new challenges that lie ahead. EPSA, with its strategic position as a Sims business, is already well placed to deliver the recovery target of 90% mandated in the Regulations.

We ensure that the public can be confident that the e-waste they bring to our collection points is recycled with maximum efficiency and environmental responsibility, and that our industry partners can trust us to deliver brand protection through compliant processes.

Accreditations and standards

We provide reassurance to customers and the community by making it clear that we operate to internationally recognised environmental, health and safety and quality management standards. These include accreditation to ISO9001, ISO14001, ISO18001 and AS/NZ 4801 as well as to R2 (Responsible Recycling). Coupled with our transparent recycling objectives, these management systems make auditing processes simpler and help strengthen trust in our services.

Operational integrity

All Sims businesses share the responsibility of managing our corporate policy, which delivers positive CSR and brand protection. We do this for ourselves and also for our industry partners, as we understand that CSR and brand protection are key drivers for companies in today's marketplace.

Like all Sims businesses, EPSA delivers services to customers that actively guard against threats, such as substandard recycling practices or unsafe work methods,

that could damage the brand of EPSA, its members, Sims or the Television and Computer Recycling Scheme itself.

SRS provides an ethically and environmentally responsible service in sustaining the lifecycle of electronic equipment. The service is delivered to the highest standards of quality and value, with the result that it contributes to both the client and the client's own customers' CSR targets.



Reach and experience

Sims Recycling Solutions (SRS) is the major strategic partner and owner of EPSA and is engaged to provide all services relating to the complete operation of the EPSA arrangement. SRS is driven by the highest standards of corporate governance and compliance and leads the way in answering the challenge of sustaining valuable resources.

As the world's leading recycler of electronic equipment, SRS has been recycling this waste stream for almost 13 years and provides the only full shredding and downstream separation process for associated e-waste products in Australia.

The company ensures legislative compliance through meeting and exceeding recycling and recovery rates and always working to the highest standards of safety and environmental protection. All material received into the SRS business is appropriately managed and processed to maximise the quantity and quality of the materials recovered.

Sims Recycling Solutions is the sole strategic partner and owner of EPSA and is engaged to provide all services relating to the EPSA arrangement.

The company's extensive global experience in this field has enabled it to develop innovative technologies which facilitate the effective and safe separation and refinement of hazardous and valuable materials from waste equipment in a way that is cost-effective and sustainable.

In Australia, SRS provides high-end, environmentally compliant solutions to the e-waste problem by providing end-of-life recycling services to many Original Equipment Manufacturers (OEMs), manufacturers, government departments, Local Government Agencies (LGAs), and businesses both large and small.

The business operates from four strategically placed locations throughout Australia: Brisbane, Sydney, Melbourne and Perth.


SRS' parent group, Sims Metal Management (SMM), is the largest tradeable scrap metal company in the world. Sims was formed in Sydney in 1917 and by the 1930s had a presence in every state.

In 2008 Sims merged with an American scrap metal recycler Metal Management to form Sims Metal Management, and is today the dominant scrap management player in the Australian market.

The use of SMM yards greatly extends EPSA's geographic reach, giving it the unparalleled ability to meet regional and metropolitan reasonable access targets.

Our performance

Our achievements in our first year of participation in the National Television and Computer Recycling Scheme have been extraordinary.

We are proud to report that we:

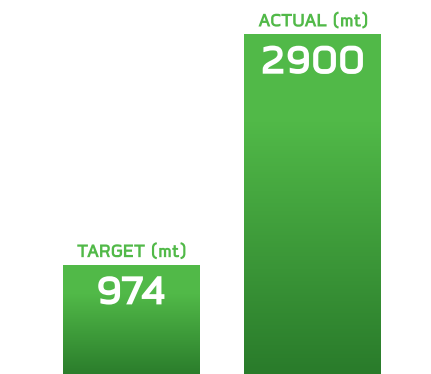
- exceeded our first year recycling target by more than 300%;
- diverted more than 2,900mt of e-waste from landfill sites;
- secured six valuable members (liable parties), including major market players;
- developed strategic relationships with key recycling and collection partners;
- delivered a fully compliant environmental solution for all e-waste collected ahead of the mandated targets for FY2015;
- collected and recycled an oversupply of products at no additional cost to members;
- provided in excess of 600 collection/drop off points nationally that covered all mandated areas (metro, inner regional, outer regional and remote) and all types of collections (permanent, event and retail);
- had no stockpiles of Cathode Ray Tube (CRT) glass during the reporting period;
- maintained a consistent collection process with assigned LGA collection points throughout the year; and
- reported no OH&S or environmental incidents in the period.



Recycling target

FY13/14 was the first year the EPSA arrangement operated under the Product Stewardship Scheme. Our arrangement attracted six Liable Parties as members (see below) for the reporting period.

A combined target of 974mt of in-scope products, to be collected and diverted from landfill sites across Australia, was set for the EPSA arrangement. We are very happy to report that the arrangement achieved more than three times this amount, collecting and diverting approximately 2,900mt at no additional cost to its members.

Reasonable access

Reasonable access is a critical outcome of the scheme. The regulation requires that the services be provided in metropolitan, inner regional, outer regional and remote locations, and that a range of collection services be offered, including but not limited to permanent points, event based collections and retailer collection points. The number of collection points and frequency of service is determined by calculations that will ensure adequate coverage of the population.

While SRS gave us access to established collection points, we needed to establish a new approach in order to deliver on the reasonable access outcomes, while at the

same time mitigating the risk of serious over-collection. Our strategy, during the latter part of the year, was to engage with other service providers to achieve the reasonable access outcome. As a result, the strategy delivered a suite of collection services including retailer collection points (65%), event-based collections (31%), and permanent points (3%).

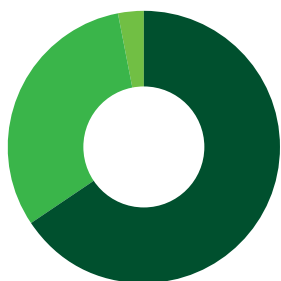
We provided collection points nationally: 48% of the collection services were provided in Queensland, 23% in New South Wales, 13% in Victoria, 7% in Western and South Australia and the remaining 9% in Tasmania and the Territories.

Our model also demonstrated that approximately 70% of the collection services were provided in metropolitan areas, a further 18% inner, 8% outer and the remaining 4% provided in the remote regions of Australia.

We provided more than 600 collection sites in the period, however this left a small shortfall of three remote collection sites to fully meet the reasonable access stipulation. This will be rectified by the end of October 2014.

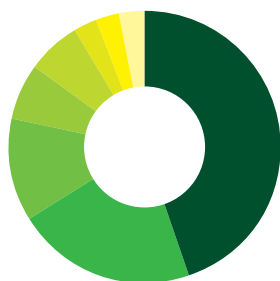

Collection methodology



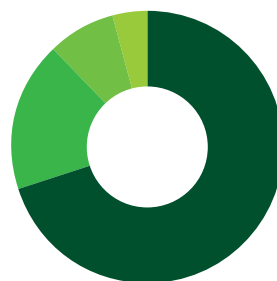
- Retailer collection points

Recovery target

While the 90% material recovery target of the Television and Computer Recycling Scheme does not apply until the FY2015 reporting period, we are pleased to report that in our first year we exceeded that target. The relationship between EPSA and SRS has placed us in the unique position of delivering the target ahead of requirements.

The chart below provides the breakdown of materials liberated from the collected products.

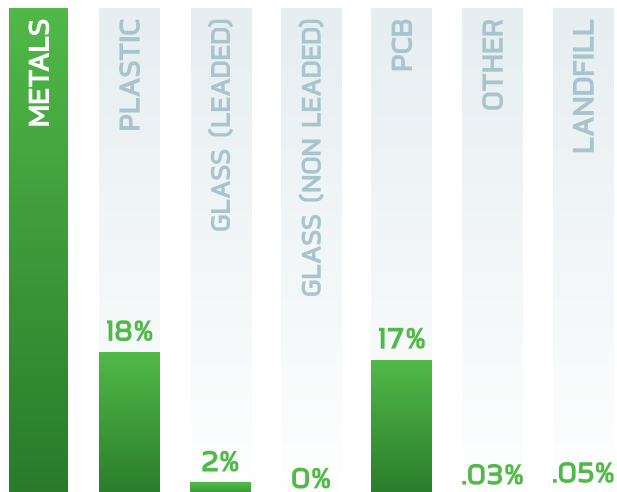
Overall, we delivered a recovery rate of 99% on the products collected based on the methodology stipulated in the Regulations.

The small quantity of materials that were liberated from the collected products and not diverted from landfill was limited to general waste such as broken pallets and some types of packaging.

Exporting

The e-waste collected by EPSA is not suitable for the resale market and exporting without an approved Basel permit is not permitted.

EPSA's key recycling partner, SRS, invests in and continues to provide innovative solutions for end-of-life recycling outcomes for this complex waste stream. The processes used by SRS are geared towards maximising the material recovered from collected products.

All the e-waste collected is mechanically or manually processed, liberating commodities for onward sale including but not limited to:

- ferrous metals;
- aluminium;
- copper;
- circuit boards;
- glass; and
- plastics.

Through SRS, the recovery of materials from the e-waste collected by EPSA is approximately 99%. Most of the commodities liberated are exported to approved downstream service providers, and all exports are fully audited and controlled under the SRS global auditing protocols.

EPSA did not export any whole units collected during the reporting period; rather recovered and returned over 2900mt of commodities back into the manufacturing stream, reducing the need for the supply of virgin material.

Recycling partners

Our stated intention has always been that we would engage with other service providers in the dismantling and recycling process as and when appropriate to meet EPSA's targets and outcomes.

As noted previously, EPSA is a wholly-owned subsidiary of SRS, which is our main recycling partner. End-of-life recycling is a core

activity for the SRS business and provides high-end environmental outcomes for all e-waste streams.

The processes are fully audited and compliant and have met with all auditing requirements from clients and other arrangements to date

In FY2013/14 SRS diverted over 16,000mt of e-waste from Australian landfill sites and recovered valuable resources both locally and overseas from their approved downstream service providers.

During the period, SRS also provided recycling services for other arrangements under the Television and Computer Recycling Scheme, including ANZRP and E-Cycle.

Environmental benefits

During the reporting period, EPSA collected and recycled all collected products in an environmentally friendly manner, and with no environmental incidents.

Our environmental achievements included:

- the diversion of approx. 2,900mt of e-waste from landfill sites in Australia;
- a recovery rate of 99% by weight, with liberated materials including but not limited to: glass, ferrous, copper, aluminium, circuit boards, packing and waste;
- minimal waste (0.05%) presented to landfill;
- the management of all final downstream processors to ensure compliance with stringent SRS audit protocols;
- appropriate dismantling and recycling of all Cathode Ray Tube (CRT) products with environmental outcomes provided for the CRT glass;
- no stockpiling of CRT glass from EPSA during the period.



Occupational health & safety

The wellbeing of our employees and the safety of those visiting our collection sites is front and centre in all that we do, and we are pleased to report that there were no OH&S incidents reported during the period.

With over 20 years of operating in the e-waste sector on a global scale, SRS understands that this is a complex waste stream with many hazards, dangers and variability that must be appropriately handled and managed through all phases of the process.

Manual handling is by far the single most contributing factor to injuries in the workplace and the risk of such injuries is evident at each and every stage in the process. We never underestimate these risks, and operate accordingly.

We have implemented appropriate processes that mitigate the risks associated with manual handling injuries, and adopt

mandatory PPE standards on all our sites. Employees who are exposed to CRT processes are also tested for heavy metals including lead levels on a regular basis.

Indeed, SRS is the benchmark for the industry, and in the early years of the development of the Regulations we hosted many tours and presentations at our facilities, paying specific attention to the safety requirements necessary for the processing of e-waste.

Communications

Our communication was specific and targeted at delivering on the outcomes of the Regulations. This included:

- specific, event-based communications; and
- communication through our retail network



Looking ahead

Overall, financial year 2013/14 – EPSA's first year of operation under the Television and Computer Recycling Scheme – closed very successfully.

We tackled many challenges and since the end of the reporting year have made further progress; our membership has increased significantly and as a result we have raised our collection target for next year by some 300%.

We have successfully secured collection points and events to ensure reasonable access stipulations are met, and as an SRS subsidiary we continue to deliver on the recovery targets mandated.



We look forward to continuing to provide our members with a reliable, safe and transparent 'arrangement of choice' that not only discharges their obligations under the Product Stewardship Act but also actively helps them meet their CSR commitments and safeguards their brands.

We tackled many challenges and since the end of the reporting year have made further progress.
