## Section A: General information

**Purpose of this form** For food importers to nominate a laboratory to perform tests required under the Imported Food Inspection Scheme.

**Before applying** The food importer/owner (or their customs broker) must contact a laboratory listed in [Section C](#) of this form to confirm that the facility can:

- perform the required tests specified on the food control certificate
- collect the samples from the Department of Agriculture, Fisheries and Forestry site
- accept the nomination.
