

Hi all

I spoke to Matthew Bickford-Smith today about EAA water. I explained that we have been waiting advice from the CEWO in regards to use of storages on the property and that I have been told we will not be able to get a definitive answer on this aspect until sometime next year (after CEWO pilot study on storages). I said that because of the long timeframe, I felt it was better to re-open discussions with him in regard to purchase of water only, and leave the more complex issue of storages for later consideration when we have the information needed.

I asked directly if he was still interested in discussing the sale to the Cth of just water and he said he would look at any offer we are prepared to put on the table. He said he has commenced negotiations for sale of the properties (including

water) and expects this to land sometime around middle of next year, but in meantime, if our offer is sufficiently interesting, he is prepared to look at this.

I did not mention the proposal for HHWUE funding.

I therefore recommend that we request the Minister's permission to put an offer for purchase of 15 GL of water (as a limited tender) before end of this year.

VALUATION METHODOLOGY FOR WATER ENTITLEMENTS ACQUIRED UNDER THE INFRASTRUCTURE PROGRAMMES

(AMENDED VALUATION POLICY)

Scope

This policy applies to the valuation of water entitlements acquired under non-cash arrangements.

Definition

A water entitlement acquired under non-cash arrangements is a water entitlement acquired under the Sustainable Rural Water Use and Infrastructure Programme (SRWUIP) including the Private Irrigation Infrastructure Operators Program (PIIOP), the On Farm Irrigation Efficiency Program (OFIEP) and Efficiency Measures grant programmes, the National Partnerships programme or as a gift to the Department.

Policy

1. When undertaking valuations of water entitlements acquired under non-cash arrangements, the fair value measurement must be based on quoted prices in an active market. If there is no active market, the value must be calculated as per step 3 below.

Active Market Procedure

- 2.1 Determine whether there is an active market by referring to the latest available annual water rights active market assessment conducted by the Financial Statements Team.
- 2.2 Where there is an active market for water access rights, then the fair value measurement must be based on the price per mega litre quoted on the relevant water entitlement market as at the date of transfer.

Non Active Market Procedure

3. Where there is no active market for water entitlements, the value of a water entitlement acquired under non-cash arrangements must be determined in accordance with the valuation hierarchy outlined in steps 3.1 to 3.5 below.

Procedure

Most recent purchase price for water entitlements acquired in last six months

- 3.1 Where, through the water purchasing tender process, the Australian Government has acquired a water entitlement of the same security type, in the same catchment, within the last six months from the date of commencement of due diligence, the price per mega litre paid in the most recent purchase transaction will be used to value the water entitlement.
 - If there have been no water buy backs during this period, then proceed to step 3.2 below.

Most recent price for a completed trade on a State Water Entitlement Register in the last six months

3.2 If the Australian Government has not acquired a water entitlement of the same security type, in the same catchment, within the last six months through the water buy-back tender process, the most recent price recorded for a completed trade on the State Water Entitlements Register will be used to value the water entitlement, provided that the price is no more than six months old.

If there have been no completed trades, then proceed to step 3.3 below.

Cost-benefit analysis of an external valuation

3.3 Where steps 3.1 or 3.2 cannot be applied, a cost-benefit analysis should be undertaken to determine whether an external valuation is required or whether the water entitlement is to be internally valued to arrive at a cost for initial recognition in the financial statements.

If the estimated (or quoted) cost of an external valuation is more than 10% of the internal estimation of the aggregate value of the water entitlements then, unless that entitlement is considered to be material in nature, the water entitlement could be valued internally.

The dollar value of water per megalitre for an internal estimation of water will be the single final reference value determined under Schedule 2 of the Intergovernmental Agreement on Implementing Water Reform in the Murray Darling Basin.

Internal Valuation Procedure

3.4 Where a cost benefit analysis concludes that an internal valuation is appropriate, then the value of the entitlement will be calculated by the Water Recovery Branch.

To mitigate the key risks associated with in-house valuations, management assumptions, the degree of subjectivity and estimation uncertainty and potential for management bias, the following needs to be clearly documented and supported, to ensure a high degree of transparency:

- i. The cost benefit analysis and factors considered to support the selection of the internal valuation methodology.
- ii. An analysis of the risks to the Department of an internal valuation.
- iii. All assumptions and factors used to derive the internal valuation.
- iv. Reports, publications, indices used in relation to the relevant entitlement market.
- v. The experience and qualifications of the staff performing the internal valuation.
- vi. Other supporting documentation, relevant to the determination and explanation of the value of the water entitlement.

The internal valuation to be applied to the water entitlement must be approved by the Assistant Secretary Water Recovery Branch.

The valuation will remain valid for use by the Department for up to six months from the date of the valuation.

External Valuation Procedure

3.5 Where a cost benefit analysis concludes that an external valuation is necessary, then the value of the entitlement is to be determined by a registered valuer. The valuation will remain valid for use by the Department for up to six months from the date of the valuation.

Additional guidance

4.1 Where there are indications that the current market price of the entitlement received is different to that derived by applying steps 3.1 to 3.3 above, largely due to a material change in factors influencing the price of water entitlements in the relevant catchment, the Assistant Secretary Water Recovery Branch may derive a valuation which utilises similar information to that utilised above.

- 4.2 If this situation arises the factors that have changed will be detailed together with their impact on the price of water entitlements and approval to vary the valuation must be sought.
- 4.3 Where references are made above to a six month time period, there is discretion to draw on information from a water purchase tender, water register of water valuation, where the six months has expired by less than or equal to seven days. However, should the Department be aware of any information to suggest that information obtained from within this seven day window is not an appropriate indicator of current market price, the hierarchy outlined above must be followed to obtain a new value.

Record keeping requirements

- 5. Supporting documentation, verifying the valuation should be kept on file for future reference and subsequent audit verification. Supporting documentation should include:
 - i. Data, inputs and assumptions used in the valuation.
 - ii. Date of transfer of the water entitlement acquired under the non-cash arrangement.
 - iii. Quoted price per mega litre in the relevant water entitlement market.
 - iv. The price list print-out from the relevant water entitlement market/catchment.
 - v. Reports/publications/indices from relevant water entitlement market/exchange used as references.
 - vi. The cost benefit evaluation of an external valuation including:
 - a. An analysis of the risks to the Department.
 - b. All assumptions and factors used to derive the internal valuation.
 - vii. Details of the officer conducting the valuation, including relevant experience and qualifications.
 - viii. Evidence that the valuations have been reviewed, with appropriate delegation approval.
 - ix. Other relevant documentation to support the valuation derived.

Relevant financial delegations/approvals

6.1 Approval for valuations

Valuations of water entitlements acquired under non-cash arrangements, must be approved by the Assistant Secretary (SES 1), prior to initial recognition in the financial records.

6.2 Approval for variation from quoted market prices

Approval to vary the value of a water entitlement will only be given where it can be demonstrated that the proposed value is a better estimate of the market value, and the means of calculating the amount accords with the Australian Accounting Standards.

- Increases of 5% or less must be approved by the Assistant Secretary Water Recovery; and
- Increases greater than 5% must be approved by the Chief Operating Officer.
