- I understand that the report of Queensland's Independent Inquiry into Equine Welfare (Martin Report) will be released shortly. Neither I nor my department have seen the report and I await its recommendations.
- My department made a written submission to the Independent Inquiry into Equine Welfare, and responded to requests for additional information.
- The Australian public has the right to expect that animals are treated humanely at all times.
- State and territory governments are responsible for animal production and welfare legislation and enforcing animal welfare laws.
- My department is responsible for ensuring the Australian export standards are complied with.
- I have full confidence that this matter will be investigated thoroughly.
- My department has informed Australia's major export market for horse meat, the European Union, of the reported animal cruelty incidents and has undertaken to provide updates as needed.
- I would urge anyone with evidence or concerns about animal welfare to report it immediately to the relevant state jurisdiction so that it can be acted upon quickly.
