Examples of product descriptions and Harmonised Commodity Description and Coding System codes (HS Code) are provided as guidance for applicants and do not represent an exhaustive list. <b>1.Casings:</b>	Refer to animal tissues that are salted or dried on the retained parts by using organs such as small intestine, large intestine and bladder of healthy livestock, after special processing such as scraping and de-oiling, and is the casing for sausage.  <i>*Note: Inedible unprocessed intestines/green runners are not considered casings products and are therefore <b>not required to be registered with GACC</b>.
