Foreword

Waste arising from end-of-life electrical and electronic products is becoming a mainstream issue as governments, industry and the media focus their attention on eWaste in Australia and globally. This includes the fate of obsolete and unwanted televisions and computers, and the environmental impacts associated with their production and consumption. The ongoing need to ensure that these products are diverted from landfill and responsibly recycled remains a high priority for key stakeholders in Australia. The bans on exports of products, from 1 July 2021, including plastics will also affect how electronics recycling is handled and processed with greater emphasis on in-country processing

As a co-regulatory arrangement under the National Television and Computer Recycling Scheme (NTCRS), MRI PSO plays an active role to recover and recycle television and computer waste through its Drop Zone collection network nationwide. Our services to the community and businesses provide a convenient and environmentally sound option that contributes to waste reduction and the transition towards a circular economy.

MRI PSO has continued to deliver a much-needed service during a challenging period of community, industry and government debate on how Australia can better manage and recycle its waste, including eWASTE.

The Victorian Government's recently introduced eWASTE to landfill ban further highlights the prominence of electrical and electronic products and how associated waste can be avoided, reduced, repaired, and/or recycled. In short there is growing acknowledgement by all stakeholders, including industry, that much more can be done to help ensure higher levels of resource recovery.

MRI PSO has maintained effective commercial operations and trade regarding materials collected through the NTCRS. Despite local, regional, and global shifts during 2019-20, it has been a challenging period that has required improved efficiencies, resourceful collaborations and focused attention on meeting community expectations and liable party obligations under the NTCRS.

Over the past few years our scheme has been successful in meeting the targets set by the regulations surrounding the Scheme. At the same time it has been successful in delivering significant productivity improvements, in particular to our liable party members. Going forward we need to carefully monitor these improvements against a backdrop of increased overview and community expectation in undertaking our services so that our improvements are reflective of all stakeholders.

MRI PSO has experienced a year of consolidation with heavy competition for liable party custom which has resulted in further reductions in fee income per tonne of product processed. This coupled with a carryover deficit, MRI made a strategic decision to reduce its target volumes. Membership numbers increased from 21 to 23

MRI PSO has maintained, as required, its collection network collection points and sourcing more volume from businesses.

MRI PSO has also maintained its investment in online promotions of Drop zone collection points and has worked closely with our members to source additional volumes from their customers. Our collections were 7,432.5 down from 10,592. tonnes. Dropzone collections decreased with consolidation in the sector volumes decreased to 2773.6 tonnes from 3,839.9 tonnes.

Taking into consideration our small surplus from prior years of 8.9 tonnes, MRI PSO recycled a total of 7,266.8 tonnes for 2019-20 leaving a surplus of 5,063.5. We have worked closely with all sectors of our collection channel including members, their customers and recycling partners to source additional volumes.

An important role for co-regulatory arrangements under the NTCRS is to provide reasonable access to communities across Australia. With the assistance of local councils, local retailers and waste collectors MRI PSO ran numerous events in remote and regional areas to ensure this was achieved,

MRI PSO's material recovery rate across all our recyclers remained high with more than 95% of the materials collected, recovered and used as raw materials for new products. This is increased from the previous year's recovery rate of 95%. The challenging marketplace for recyclates offshore has continued to have an impact on pricing and demand. A focus for our industry and the Australian community at large will be to develop domestic markets for recyclates to make the Australian market more resilient and meet the requirements of the new export bans introduced by the Federal Government.. MRI PSO is pleased to have met its material recovery target despite the disruptive international marketplace for recyclates.

Without the support of liable parties and our partnerships with local councils, retailers, transporters, recyclers and social enterprises, MRI PSO could have not achieved these solid results.

OUTCOMES

In achieving the outcomes and meeting the requirements in the regulations, MRI PSO has worked hard to achieve all the targets that have been in place under the NTCRS. While continuing to achieve the resource recovery rate and providing reasonable access to the community. MRI PSO did meet its collection target for the year.

RISK MANAGEMENT

MRI PSO is mindful of the associated risks of being an approved co-regulatory arrangement under the NTCRS. The directors and senior managers are part of continuous improvement processes of MRI PSO's performance through regular management reviews where strategies are assessed to ensure that they will meet the Scheme objectives and minimise any risk for the Scheme, liable parties, collectors, transporters, recyclers and MRI PSO. Internal and external auditors are employed on a regular basis to ensure that MRI PSO's operations are compliant with all relevant OH&S and environmental regulations and the Scheme outcomes and objectives as specified in the Product Stewardship (Television and Computer) Regulation 2011 and Product Stewardship Act 2011. MRI PSO continues to comply its obligations under the Scheme.

ADMINISTRATION

MRI PSO's scheme is operating to a high standard. At this point there is no requirement in place to replace the Administrator. Should the situation change MRI PSO's policies and procedures would allow for an effective and seamless transfer of responsibilities to an alternate Administrator.

Through regular meetings all our liable parties have been kept informed of how MRI PSO has progressed throughout the year with collections, reasonable access, and resource recovery targets.









Free accessible collection network for householders and small business.

MRI PSO's free collection service for householders and small business involves a combination of 149 permanent and event-based collection sites including retailer sites located in metropolitan, inner regional, outer regional and remote areas across Australia.

MRI PSO's primary focus for collection services is on permanent collection sites which are associated with council waste transfer stations. This year we also conducted over 43 e-waste events in regional and remote locations.

The rationale for this is based on householder and small business familiarity with disposing of waste at council and continuity of service. As well as the ability to expand on existing council to encourage the community to take televisions and computers to the same facilities.


COLLECTION SITE PROMOTIONS


ADVERTISING

Leading Edge Computers assisted the co-regulatory arrangement in promotions by advertising events at regional locations in-store at point of sale.

MRI PSO also advertised and promoted its e-waste events across regional and remote Australia in local papers and online.









Recycling Activities

RECYCLERS

MRI PSO engaged eight recyclers, operating across 9 facilities nationally to process product in 2019-20. Three of these recyclers work in conjunction with social enterprise firms that provide job opportunities for people with disabilities and long-term unemployment. All recyclers using a disability workforce comply with the relevant state and territory legislation, as well as the federal laws.

Overall MRI PSO achieved a material recovery rate of 95% in 2019-20.

To ensure compliance with all relevant OH&S, environmental regulations and AS/NZS 5377:2013, MRI PSO conducted separate audits of each recycler. This included verifying certifications, downstream processing, material recovery rate calculations and sourcing of product outside of that collected from MRI PSO's collection network Drop zone. Each recycler and their downstream processors have measurable landfill diversion rates of more than 90%.



MRI PSO also worked closely with transporters and collectors to ensure that handling, storing and processing e-waste are consistent with AS/NZS 5377:2013.



EXPORTED WHOLE UNITS

There were no whole units of televisions, computers or computer product exported overseas for recycling or re-use. MRI PSO's selected recyclers all have varying downstream processes which may see components exported overseas for further processing. These recyclers and their downstream processes have been audited in accordance with the NTCRS Regulations and AS/NZS 5377.

OH&S and ENVIRONMENTAL MANAGEMENT

MRI PSO works closely with recyclers to review and identify areas of opportunity in the Employee Health and Safety and Environmental Management areas. Through the annual audit program and quarterly reporting any issues identified are actioned and rectified in a timely manner.

No major issues were identified and there were 3 notifiable Environmental Incidents reported for the period and no OH&S incidents reported .
