* The following state/territory industry FMD accounts and holdings have been aggregated with the respective New South Wales industry FMD accounts and holdings where there are less than 20 accounts for privacy reasons:

- Victoria – *sugar, pig, and other*
- Queensland and South Australia – *other*
- Western Australia – *sugar, pig, and other*
- Tasmania – *grain, pig and other*
- Australian Capital Territory and Northern Territory – *horticulture, crops, grain, grain-sheep/beef, sheep-beef, sheep and forestry & fishing*

These monthly FMD statistics are derived from data provided by Authorised Deposit-taking Institutions (ADIs) (such as banks and credit unions). These statistics may, due to the complex nature of FMDs, include a level of discrepancy, leading to a minor overstatement or understatement of the actual holdings eligible for the FMD taxation concessions.
