NOTICE TO INDUSTRY 18

Guide to import fees for horses

Introduction

The purpose of this Notice to Industry (NTI) is to clarify the fees that may be charged by the Department of Agriculture, Fisheries and Forestry for horse imports to Australia effective 1 July 2024. This includes examples of activities that apply for the fee types listed. Import permit fees

All horses intended for import to Australia must have a valid import permit from the department. Import permit lodgement and assessment fees apply per consignment of horses.

Note: Additional fees apply to all permit and variation application types if the assessment time exceeds 3 hours. Additional time is charged as an in-office fee of \$39 per 15 minutes. For example, this may apply to shuttle stallion equine viral arteritis assessments.

Fees for import permit applications are required at the time of lodgement. An import permit will not be granted until payment is cleared. Payments do not process on the day the application is submitted. The lodgement fee is non-refundable once the application has been submitted. Once an import permit application or variation application has been assessed, regardless of outcome, no refund can be issued. This is because the services provided by the department have been expended.

Clearance fees – in-office and at airport

The clearance fees detailed in the table below include the time taken for departmental officers to assess documentation in-office as well as inspecting horses on arrival at the airport. The time taken to clear horse stalls and equipment are charged on a separate invoice. These invoices will be generated through the AIMS system.

*Where the inspection of horses at the airport is for a consignment with multiple importers, fees are split according to the ratio of horses per importer.

Importation charge – Mickleham Post-Entry Quarantine Facility

Since 1 July 2023, an importation charge for all horse imports applies. The importation charge includes but is not limited to:

- Biosecurity officers time for routine requirements including between 5:30am – 10pm daily x 14 days PAQ, preparation of the compound including documents and compound set up, arrival, release day, forklift spotting
- Veterinary officers time for supervision for all routine testing, routine examinations, arrival and release
- Horse, Livestock and Bird Imports program technical advice, procedures, training, verification and support
- Support staff and overheads including: security, HR and training
- Contractor expenses – e.g. Forklifting Feed & Bedding; Bunker Rake Operation and Post Intake repairs
- Utility costs - gas, electricity, and water
- General Waste - incl collection and distribution
- Biosecurity Waste - incl fuel surcharge and portion of monthly fee
- Consumables - towels, overalls, shampoo & conditioner etc
- Minor Equipment - tools, rakes, shovels, kettles toasters, microwaves, etc
- Repairs & Maintenance – e.g. surgery equipment, horse walker, float, gurneys, menage sand, decontamination equipment
- Vehicle Lease - Polaris

The importation charge is comprised of a non-refundable reservation charge (20%) which will apply when booking a horse consignment at Mickleham Quarantine Post-Entry Quarantine Facility (MQF) and the balance of this importation charge (80%) which will apply prior to the consignment's arrival.

Bookings and fees for the privately operated Approved Arrangements (AAs) for horses are not determined by the department and must be discussed with the individual operator of the AA.

MQF non-refundable reservation charge

A non-refundable reservation charge (20%) will be invoiced to the importer based on the number of horses confirmed to arrive within the consignment up to 22 days prior to their importation. Refer to [Making a horse compound booking at the Mickleham Quarantine Facility](#).

MQF balance of importation charge

The balance of the importation charge (80%) will be invoiced to the importer based on the number of horses within the consignment due to arrive from overseas. This invoice will be issued approximately one to two business days prior to their importation.

MQF additional charges

Additional charges that may be incurred during the quarantine period will be invoiced upon release of the consignment from MQF.
