




Key points


- Most global beef supply growth is currently coming from South America

- Exportable supply in Oceania will be down in 2021. North
 American and EU growth will not keep up with population
- China has emerged as the top beef market in the world and South America slowly transforming to core supplier

















Exporter Supply Growth Trends: 2015 - 2020



China this year accounts for:


- +75% of Argentina exports







China Share of Argentine and Uruguay Beef Exports




