### This Privacy Policy Summary

The Department of Agriculture, Fisheries and Forestry (the **department**) respects your right to privacy and complies with the *Privacy Act 1988* (Cth) (**Privacy Act**) in relation to handling your personal information.

- the kinds of personal information the department may collect and hold about you and other individuals;
- how the department may collect, use, store and disclose your personal information, and for what purpose; and
- how to access and/or correct your personal information that is held by the department.

This summary provides you with an overview of these matters.

#### Personal information collected by the department

The department will generally collect your personal information directly from you, unless it is unreasonable or impracticable to do so, or required by law. There may be times when the department may collect personal information from your authorised agent or a third party.

The department collects and holds different types of personal information to perform its functions and activities, including:

## Why the department collects, uses and discloses your personal information

The department collects, uses and discloses your personal information to perform its functions and activities. Unless an exception applies, the department will:

- only use or disclose your personal information for the purpose it was collected; and
- notify you of this purpose at the time of collection, or as soon as practicable after collection.

The department will only use or disclose your personal information for another purpose where this is permitted by the Privacy Act or another law.

### How to access and correct your personal information

To request access or correct your personal information held by the department:

- If you are a member of the public or an external stakeholder submit a request via email or letter to the relevant business area within the department. For example, applicants for a grant program should first contact the program administrator;
- If you are a current or former employee, or workforce contractor please contact People Services Branch, or use the general contact details at the end of this summary.
