

## Senate Order for Entity Contracts - 2019 Calendar Year

Pursuant to the Senate Order for Entity Contracts, the Director of National Parks provides a list of contracts valued at or above \$100,000 (GST inclusive) that were:

•Entered into prior to 1 January 2019, and not fully performed as at 31 December 2019; and/or •Been entered into during the 2019 calendar year.

Most of the contracts listed contain confidentiality provisions of a general nature that are designed to protect the confidential information of the parties that may be obtained or generated in carrying out the contract. The reasons for including such clauses include ordinary commercial prudence and/or the protection of: trade secrets, proprietary information, Commonwealth material and personal information.

The accountable authority of the Director of National Parks has assured that the listed contracts do not contain any inappropriate confidentiality provisions.
