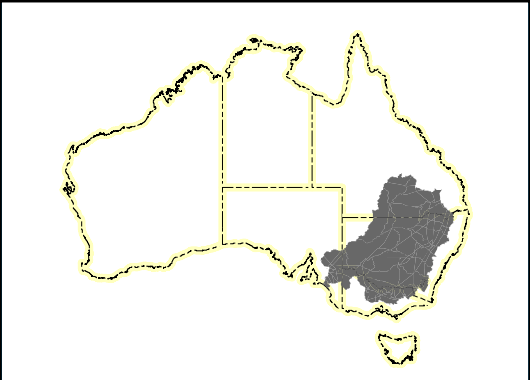

*Bidyanus bidyanus*

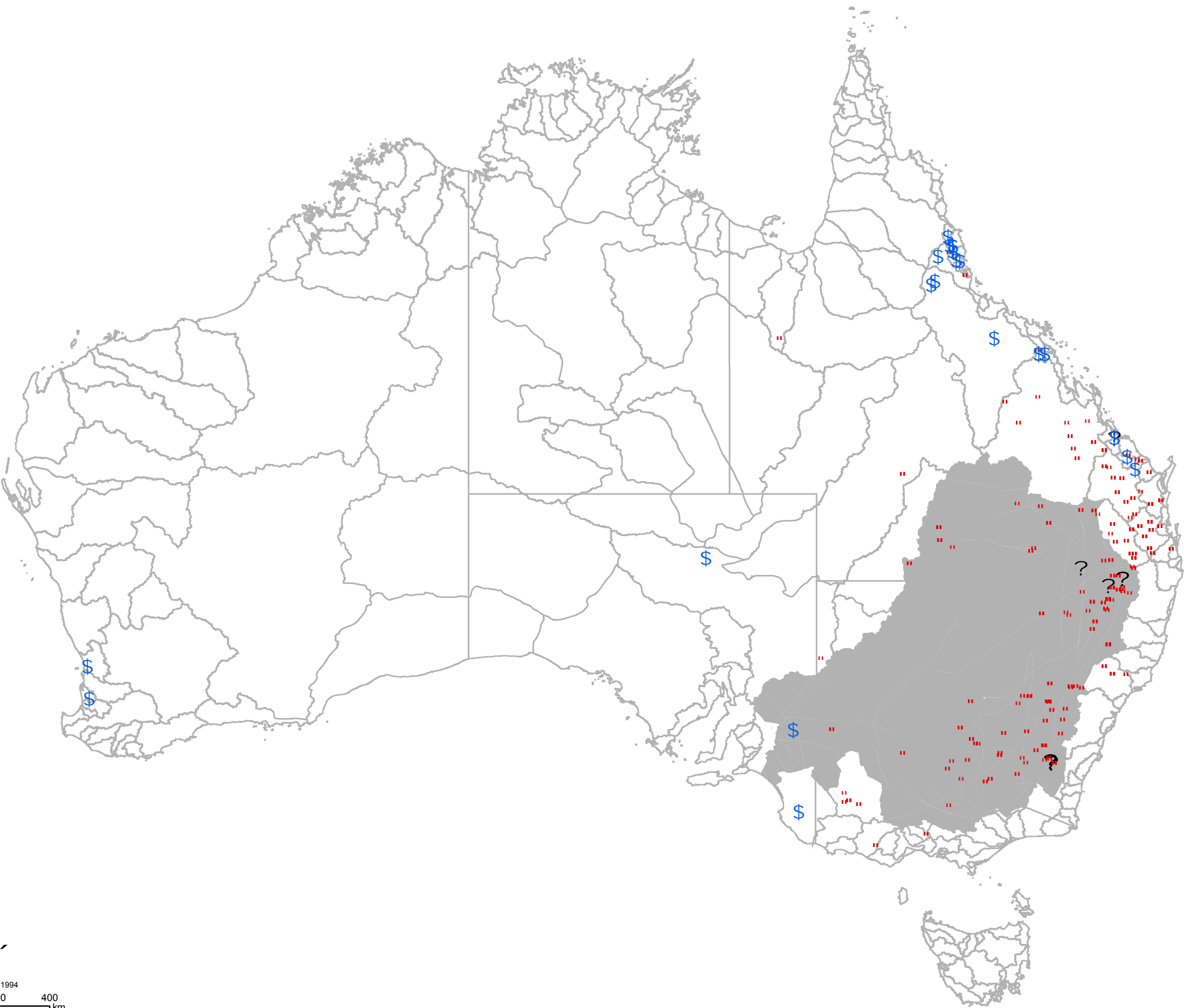

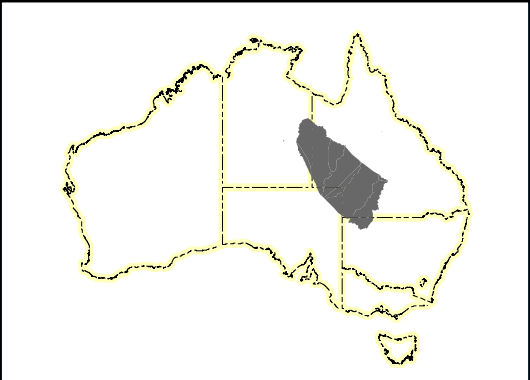

*Oxyeleotris lineolata*



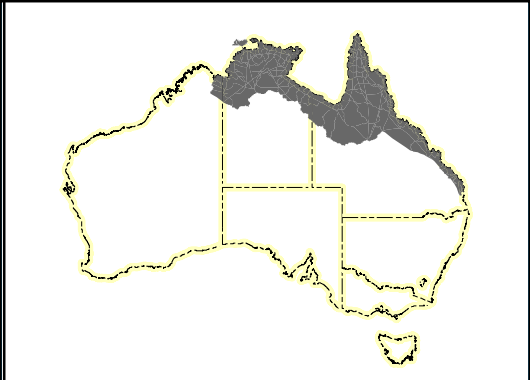

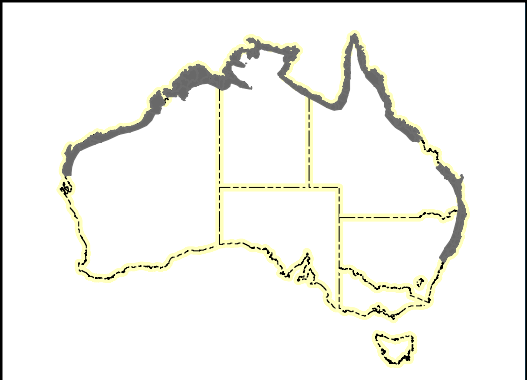

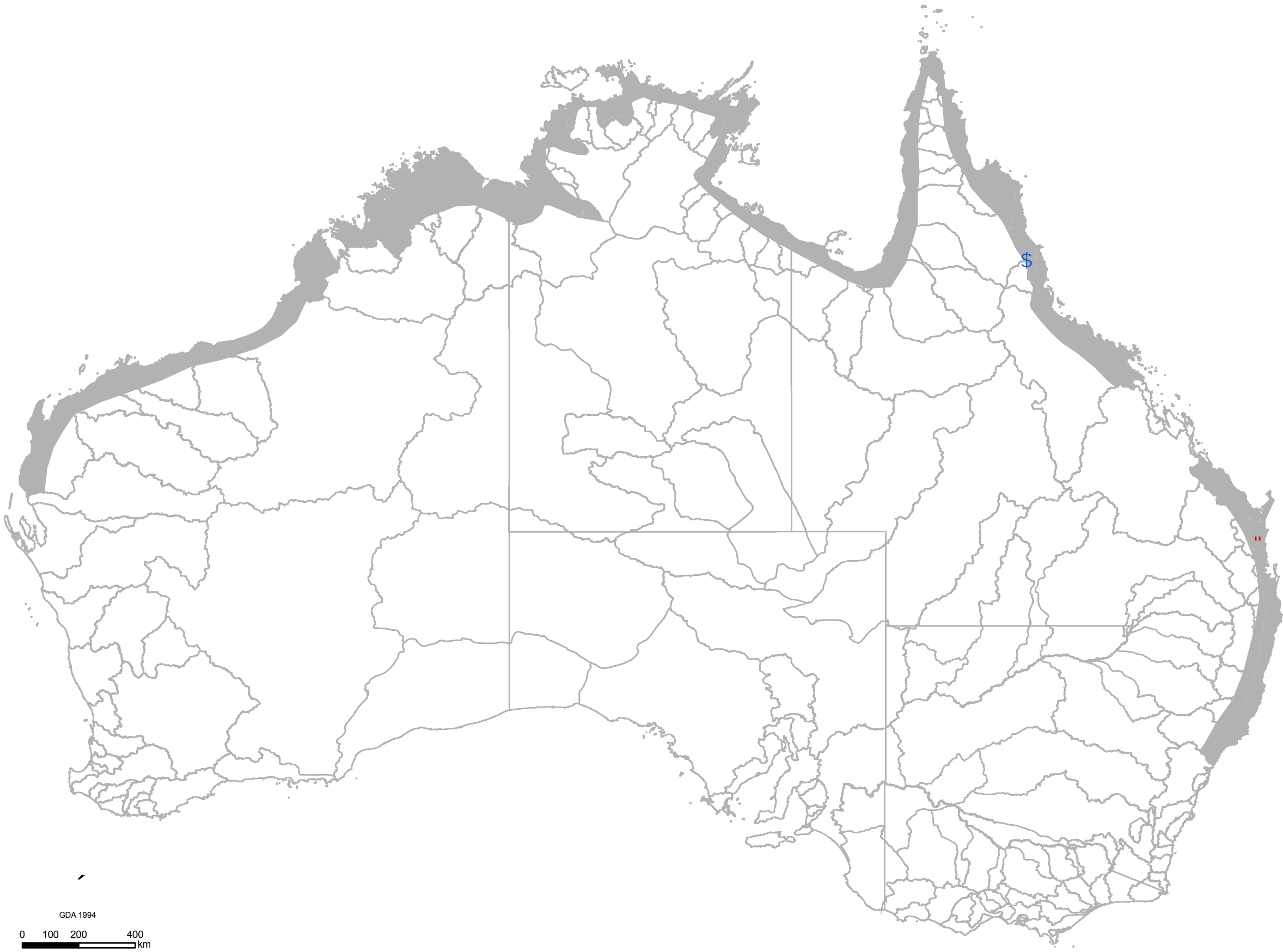

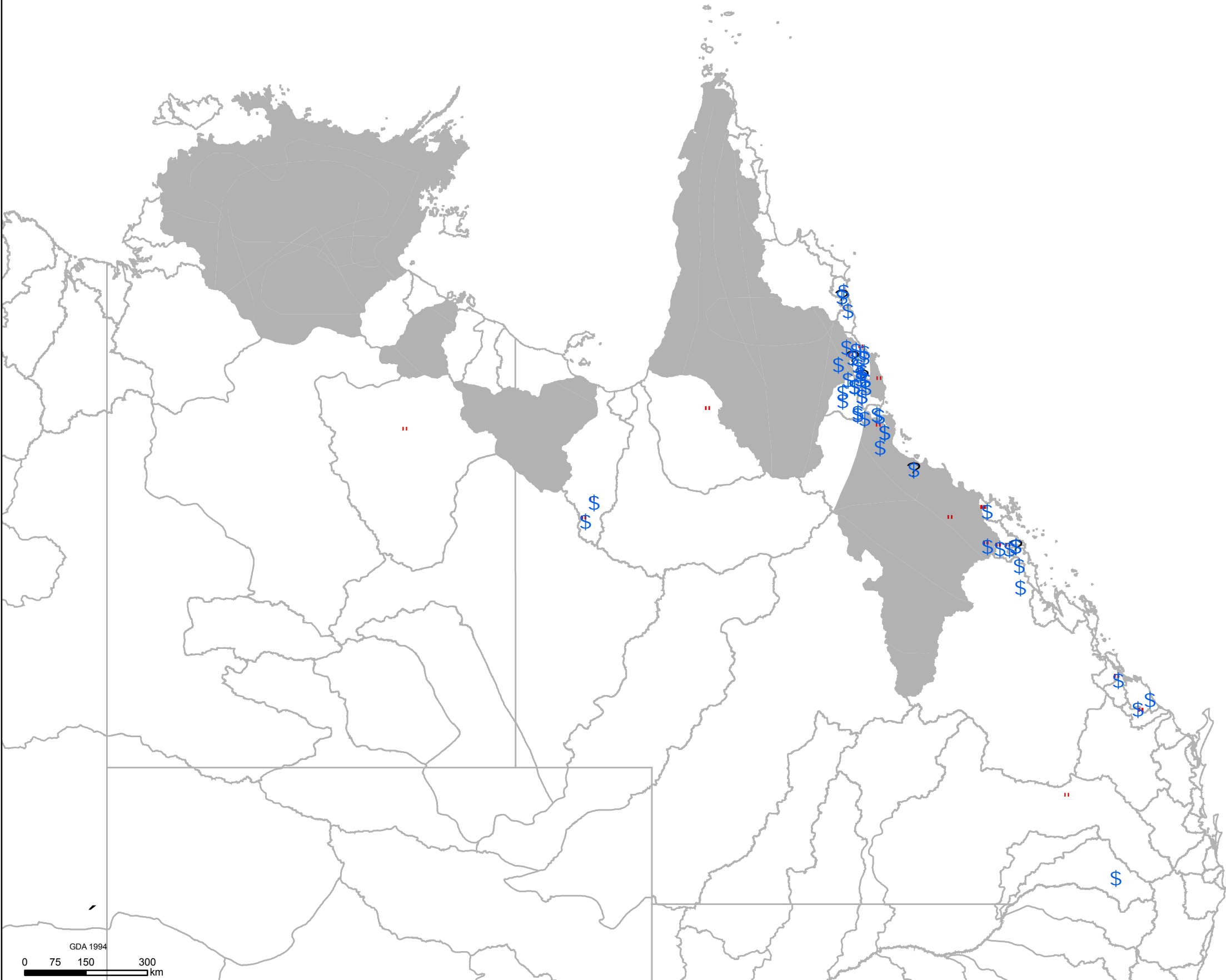

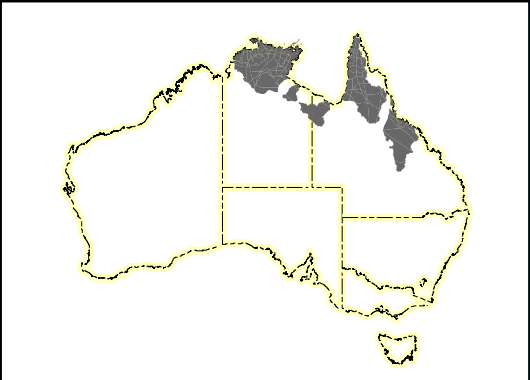
