The National Pollutant Inventory (NPI) provides information on the web about pollutant emissions from industrial facilities and diffuse sources, their possible impact and what you can do to decrease emissions.

The NPI is a cooperative programme implemented by the Australian, State and Territory Governments.

This is the first NPI newsletter by the Australian Government Department of the Environment and Heritage (DEH) for some time.

Publication of NPI data: January 2005

On 31 January 2005 the DEH published the new industry facility data on the web. This data is determined by facility operators for their facilities, then provided to states and territories for assessment and finally forwarded to the DEH to publish.

An overview is provided that outlines some key sults from the data:

NPI overview

As in previous years particular industry sectors and substances were focused on to demonstrate how NPI data can be used.

The industry sectors focused on were:

- Intensive animal raising
- Cement and lime manufacturing

The substances focused on were:

- Formaldehyde emissions
- <u>Total volatile organic compounds</u> <u>emissions</u>

In 2003-04 motor vehicles remain the chief cause of pollution in Australia.

Review of the NPI

A review of the NPI commenced in March 2005.

The review aims to determine the NPI's effectiveness and whether it is delivering benefits to the community, industry and governments. Stakeholder consultation was scheduled for March 2005.

The results of the NPI review will be presented to the Commonwealth, State and Territory Ministers in July 2005. These Ministers make up the Environment Protection and Heritage Council (EPHC).

The review will provide a starting point for Ministers to consider whether to change the design of the NPI, and the scope of any change.

Cleaning up with the NPI – a course in professional practice:

Dates: 6 and 7 June 2005

Venue: Griffith University, Nathan Campus,

Brisbane

Cost: \$595 or \$560 for members of professional associations and \$450 for students/concessions.

This two-day course will provide environmental managers, staff in industry and consultants with the key competencies required for reporting to the NPI. It will also cover some of the fundamental concepts of advanced environmental and sustainability reporting.

Participants will be presented with a Certificate of Competency from Griffith University on successful completion of the course.
