Successful applicants will then be emailed with the link to the next form.

Sale Close Time: We will issue a Sale Closure Notice once the number of Eligible Applications received equates to a volume of water allocations which exceeds the Sale Volume. This notice will be published advising the Sale Close Time, which will be at 10:00am AEDT on the day after the notice is published. Applications can be submitted until the 10:00am AEDT on the day after the notice is published.
