



#### **SECTION E: Privacy notice**

'Personal information' means any information or opinion about an identified or reasonably identifiable individual.

The collection of mandatory personal information as denoted by an asterisk (\*) is authorised by the *Primary Industries Levies and Charges Collection Act 1991* (the Act) and the Primary Industries Levies and Charges Collection Regulations 1991 for the purpose of administering the dairy produce levy. If you do not provide the mandatory information requested in this form, you will be in breach of the Act and the Department of Agriculture, Water and the Environment may be required to take action.

Dairy Australia has asked that the department to also collect additional information about producers. The additional information that is being requested is located in the 'Voluntary information' field on the producer information page of the return form. Providing this information to the department is not required under the Act and is voluntary. Should you choose to complete this part of the return, the information will be passed on to Dairy Australia, and will be used to allocate voting entitlements and facilitate outreach with levy payers more effectively.

The department may disclose your personal information to industry bodies and levy recipient organisations, and other Australian government agencies, persons or organisations where necessary for the above purposes, provided the disclosure is consistent with relevant laws, in particular the *Privacy Act 1988* (Privacy Act).

The information collected by the return may be given to Dairy Australia by a person appointed by the Secretary of the department in accordance with the Act. The Act restricts the use of the information by Dairy Australia. Dairy Australia may not disclose the information given to it to any other person or body except with the approval of the Secretary of the department. Any person or body which has the information disclosed to them by Dairy Australia may only use it for certain purposes or activities prescribed by the Act.

Your personal information will be used and stored in accordance with the Australian Privacy Principles.
