## Introduction

This document lists amendments that have been identified for Version 8.1 of the Exporter System Interface Specification issued February 2002. It follows Errata Set 33. Please update your copy of the specification as appropriate.

Within the following document where there are changes to segment or data rules the entire segment has been reproduced with the changes to the rules underlined. Where text has been deleted the text is displayed in the sections below with lines through the text. Where text has been added the text is underlined in the sections below.



## **1** Amended Information

An enhancement has been made to the EXDOC application requiring the addition of a field that contains the comments from the exporter when specific fields are changed as to why the amendments are required for Horticulture and Grain products.

The following segment should be inserted into the *RFP Amend Message* between the GR0 RFF segment that contains Exporter Reference and the GR0 MOA segment that contains FOB Currency Unit.

An enhancement has been made to the EXDOC application requiring the addition of a field that indicates if the product is Halal approved.

The following segment should be inserted into the *RFP Order Message* between the GR11 ATT segment that contains Ungraded Product Indicator and the GR11 DTM segment that contains Durability Start date.

#### 5.1.3.x Reason 16 (Order): GR11 ATT (Role – Halal Product Indicator)

Segment Rule: Optional. Where present, data elements are validated for format and, if <u>coded, must conform to the relevant Data Rule as specified for Lodge RFP,</u> <u>otherwise not validated.</u> Segment Rule: An owner LIN must be present.

## **3** Approved Certifier

An enhancement has been made to the EXDOC application requiring the addition of a field that indicates the Approved Certifier.

The following segment should be inserted into the *RFP Order Message* between the GR9 PNA segment that contains Storage Establishment Number and the GR11 LIN segment that contains Line Identifier.

#### 5.1.3.x Reason 16 (Order): GR9 PNA (Role – Approved Certifier)

Segment Rule: Optional. Where present, data elements are validated for format and, if coded, must conform to the relevant Data Rule as specified for Lodge RFP, otherwise not validated.

The following segment should be inserted into the *RFP Lodge Message* between the GR9 PNA segment that contains Storage Establishment Number and the GR11 LIN segment that contains Line Identifier.

## 4 Average Age of Animals

An enhancement has been made to the EXDOC application requiring the addition of a field that specifies the average age of the animals exported.

The following segment should be inserted into the *RFP Order Message* between the GR0 FTX segment that contains Lot Number and the GR0 MEA segment that contains Transhipment Storage temperature.

#### 5.1.3.x Reason 16 (Order): GR0 FTX (Role – Average Age of Animals)

Segment Rule: Optional. Where present, data elements are validated for format and, if coded, must conform to the relevant Data Rule as specified for Lodge RFP, otherwise not validated.

The following segment should be inserted into the *RFP Lodge Message* between the GR0 FTX segment that contains Lot Number and the GR0 MEA segment that contains Transhipment Storage temperature.

Both segments in Order (16), Lodge (13), Reissue (18) messages and SANCRT Adaption & Data Item Mapping (Appendix A) will move from current location to just after the segment GR11 DTM that contains Salting date.
