Definitions

1. In this licence:

"department" means the Australian Government Department of Agriculture, Fisheries and Forestry.

"exporter" means **XXXX Pty Ltd**, of [address].

"[species common name]" means the species [species botanical name].

Export Limitations

2. This licence is for a maximum of **XXXX** tonnes of [species common name].

Source Material

3. All [species common name] exported under this licence must be from the following locations:

4. The exporter shall not:

(a) carry out logging operations for the purpose of export under this licence from any area which has been entered on the Register of the National Estate or placed on

the Interim List of the Register of the National Estate or from any area where logging could adversely affect a National Estate area; nor

(b) export logs and limbs removed from any area which has been entered on the Register of the National Estate or placed on the Interim List of the Register of the National Estate.

Environment Protection

5. The exporter must comply with the requirements of the [State] Government and all relevant local authorities to ensure that all operations connected with the export of [species common name] under this licence are conducted so as to prevent significant impacts on the environment.
6. The exporter must comply with the requirements of the Australian Government, in particular the requirements of the *Environment Protection and Biodiversity Conservation Act 1999*, to ensure that all operations connected with the export of [species common name] under this licence are conducted so as to prevent significant impacts on areas of national environmental significance.

Inspection

7. The exporter must facilitate the inspection by officers of the [State] Government and/or Australian Government of any area where operations connected with the export of [species common name] under this licence are being carried out.

Reporting

8. The exporter shall, on request, provide the department with a report relating to compliance with all, or any, of the conditions of this licence.
9. The exporter shall, on request, provide the department with a copy of the final sales invoice on a commercial-in-confidence basis within 30 days of date of export.

NOTE:

Failure to comply with the conditions or restrictions in an export licence is an offence under the *Export Control Act 1982*. Under the Regulations the minister or his delegate may also suspend or revoke the licence in certain circumstances.
