PLANT BIOSECURITY POLICY MEMORANDUM 2000/27

IMPORT RISK ANALYSIS -FRESH APPLES FROM NEW ZEALAND

This Plant Biosecurity Policy Memorandum (PBPM) advises stakeholders that the period for comments on the draft Import Risk Analysis (IRA) paper on the importation of fresh apples from New Zealand has been extended to 28 February 2001.

In PBPM 2000/18 stakeholders were invited to comment on the draft IRA paper for the importation of fresh apples from New Zealand. The period for comment on the draft Import Risk Analysis closed on 11 December 2000 and Biosecurity Australia has received more than 100 submissions.

After careful consideration, and to ensure that no one is denied the opportunity to have input into this important policy making process, Mr Michael Taylor, Secretary of the Department of Agriculture, Fisheries and Forestry - Australia (AFFA) has decided to extend the period for interested parties to lodge written submissions until the end of February 2001. This decision has not been taken lightly and has been made in the best interests of all parties involved. It is about achieving the most scientifically rigorous outcome possible.

Stakeholders who provided written submissions during the consultation period would have already received advice of the extension under separate letter from Mr Michael Taylor. All groups or individuals that have provided submissions are invited to review and modify their submissions or to provide supplementary information on the draft IRA. Interested parties who have not yet provided comments are encouraged to do so.
