ANIMAL BIOSECURITY POLICY MEMORANDUM 2001/14

DENMARK: LIFTING OF TEMPORARY FMD RESTRICTIONS

This Animal Biosecurity Policy Memorandum (ABPM) advises stakeholders of the lifting of the temporary foot and mouth disease (FMD) restrictions on product from Denmark, effective 12 July 2001.

The Director of Quarantine has approved the lifting of the temporary FMD restrictions on product from Denmark. This decision takes effect from 12 July 2001.

On 14 March 2001, Australia temporarily suspended imports of animals susceptible to FMD and their products from the European Union (EU) and other countries where FMD is present. As part of the undertaking to review the temporary restriction, Biosecurity Australia sent a questionnaire to the embassies of each Member State and the EU delegation in Canberra. The questionnaire was based on the Office International de Epizooties (OIE) International Animal Health Code definitions for FMD free zones and included key epidemiological data identified as significant by Australian veterinarians who had participated the UK eradication campaign.

Denmark has provided a detailed response which presented all the necessary information to confirm its FMD-free status. It has been free of FMD since 1983 and is on the OIE List of FMD-free countries.

Two of the main items imported from Denmark are pig meat and dairy products.
