ANIMAL BIOSECURITY POLICY MEMORANDUM 2001/19

FRANCE AND BELGIUM: LIFTING OF TEMPORARY FMD RESTRICTIONS

This Animal Biosecurity Policy Memorandum (ABPM) advises stakeholders of the lifting of the temporary foot and mouth disease (FMD) restrictions on product from France and Belgium, effective 7 August 2001.

The Director of Quarantine has approved the lifting of the temporary FMD restrictions on product from France and Belgium. This decision takes effect from 7 August 2001.

On 14 March 2001, Australia temporarily suspended imports of animals susceptible to FMD and their products from the European Union (EU) and other countries where FMD is present. As part of the undertaking to review the temporary restriction, Biosecurity Australia sent a questionnaire to the embassies of each Member State and the EU delegation in Canberra. The questionnaire was based on the Office International des Epizooties (OIE) International Animal Health Code definitions for FMD free zones and included key epidemiological data identified as significant by Australian veterinarians who had participated in the United Kingdom (UK) eradication campaign.

France has provided a detailed response that presented all the necessary information to confirm its FMD-free status. There were two outbreaks which were detected on 12 and 23 March 2001. France has supplied information on its control and eradication measures as well as its tracing, surveillance, monitoring and prevention activities. The eradication measures included the slaughter of the infected herds, susceptible species within the potential area of airborne spread of the virus and those linked in epidemiological terms to the outbreaks. The French were able to trace animals imported from the UK, Netherlands and Ireland during the danger periods which were culled along with all animals of susceptible species in contact with them.

Under OIE rules, a country formerly free from FMD without vaccination regains that free status three months after the last reported outbreak if no vaccination occurred.

Genetic material and dairy products produced from milk collected between 5 February and 23 June 2001 from France will not be eligible for importation.
