PLANT BIOSECURITY POLICY MEMORANDUM 2001/16

REVIEW OF POST-ENTRY QUARANTINE PROTOCOLS FOR THE IMPORTATION INTO AUSTRALIA OF APPLE (MALUS) AND PEAR (PYRUS) BUDWOOD

This Plant Biosecurity Policy Memorandum (PBPM) provides information regarding the Review of Post-Entry Quarantine Protocols for the Importation into Australia of Apple (*Malus*) and Pear (*Pyrus*) Budwood

In response to concerns about the length of time taken for introductions of apple (*Malus*) and pear (*Pyrus*) budwood to pass through post-entry quarantine, The Australian Apple & Pear Grower's Association Inc. funded the Victorian Department of Natural Resources & Environment (DNRE) to undertake a review of current testing protocols.

DNRE released their report "Proposed Post-Entry Quarantine Protocols for Pome Fruit" in 1998. This report recommended using the latest *in vitro* diagnostic techniques for pathogen detection to reduce the time for entry of new apple and pear material into Australia from four years to twelve months. Furthermore, the report recommended the list of quarantine pests be modified to include additional bacteria, fungi, phytoplasmas and viroids, and to have certain viruses and graft-transmissible diseases of unknown aetiology deleted.

Biosecurity Australia (BA) has reviewed the pathogen risks associated with the importation of apple and pear introductions, considered the recommendations of the DNRE report and presented future requirements for post entry quarantine (PEQ) and pathogen testing for the quarantine pathogens associated with budwood.

Biosecurity Australia (BA) has now completed a "Draft Review of Post-Entry Quarantine Protocols for the Importation into Australia of Apple (*Malus*) and Pear (*Pyrus*) Budwood" and the draft paper is enclosed.

You are invited to comment on the issues raised in the draft review paper. BA will accept written submissions until the close of business Tuesday 16 October. Submissions should be sent to the following address:
