ANIMAL BIOSECURITY POLICY MEMORANDUM 2002/25

IMPORT RISK ANALYSIS: PSITTACINE BIRDS

PROGRESS REPORT

This Animal Biosecurity Policy Memorandum (ABPM) provides stakeholders with a progress report on, and the next steps in, the Import Risk Analysis (IRA) of psittacine birds and eggs.

A technical issues paper for this IRA was released for public comment in December 1999. Eight stakeholders commented on the paper. Since that time the Risk Analysis Panel has met formally on a number of occasions: 10 April 2000, 22 June 2001, 20 July 2001, 22 February 2002, 28 March 2002 and 1 and 2 May 2002.

The panel has considered the stakeholder comments on the technical issues paper and has, more recently, been developing the draft IRA report, the next consultation step. The IRA follows the *IRA Guidelines*, a template for developing the IRA reports, established by Biosecurity Australia. A copy of the Guidelines is available from Biosecurity Australia's website (www.affa.gov.au/biosecurityaustralia - follow the links to 'IRAs' and then 'review of IRA process'). The psittacine birds panel is one of the first groups to conduct an IRA using the template.

It was originally anticipated that the draft IRA report would have been released some time ago. However, the panel has devoted considerable time to carefully considering the methods for evaluating the pest and disease risks, including the release and exposure pathways. The panel has also focussed on making sure the analysis is soundly based and well documented.

The last panel meeting was held in Canberra on 1 and 2 May 2002 and the panel took the opportunity to visit a major breeding aviary outside Canberra to ensure that it is fully conversant with current biosecurity practice within industry, as well as to make sure that the consequences of a disease outbreak are considered in full in the IRA. The panel also made good progress on the draft IRA report and resolved a number of outstanding issues.

Next Steps

It is expected the panel will need to meet formally on at least one more occasion to finalise the draft IRA report. The next meeting is planned for 4-5 July 2002. The draft IRA report is circulated for 60 days public comment. Following consideration of stakeholder comments, the panel will be able to finalise the IRA.
