PLANT BIOSECURITY POLICY MEMORANDUM 2002/14

IMPORT RISK ANALYSIS – FRESH MANGOSTEENS FROM THAILAND

This Plant Biosecurity Policy Memorandum (PBPM) advises stakeholders of the outcome of the first round of consultation regarding the Import Risk Analysis (IRA) on the importation of fresh mangosteen from Thailand.

Plant Biosecurity Policy Memorandum (PBPM) 2002/06 of 18 February 2002 advised stakeholders of the commencement of an IRA on the importation of fresh mangosteen from Thailand and invited comments on the proposed scope of the analysis, the indicative timetable and the use of an in-house risk analysis team.

It was proposed that the IRA consider quarantine risks associated with pests and diseases of mangosteen from Thailand and subject to no unforeseen difficulties, that the IRA would take approximately 18 months to two years. We also proposed that a team of technical experts from within Plant Biosecurity conduct the IRA.

The team leader for this IRA is Dr TK Lim, who currently is the Manager of the South Asia and Middle East Team. Dr Lim will be drawing upon the expertise of Biosecurity Australia's pool of plant pathologists, entomologists, risk analysts, weed scientists, disinfestation specialists and quarantine operations specialists to conduct the IRA. All of the in-house specialists have been involved in varying degrees in the following risk analyses: table grape, apple, apple & pear budwood, bulbs, longan and lychee, mango, mushroom, sweet corn, maize, durian, ya pear, timber, pineapple, olive, papaya and citrus.

Executive Manager's decision

Five comments from four stakeholders were received in response to PBPM 2002/06. Following consideration of PBPM 2002/06 and the stakeholder comments, the Executive Manager of Biosecurity Australia has confirmed the scope, indicative timetable and approach as set out above.

Next steps

As previously advised, the review of the IRA process is well advanced. One of the issues that has arisen from the review is the need to extend the opportunity for stakeholders to appeal at an early stage in all IRAs. The current draft of the IRA

process, circulated in September 2001, provides for stakeholders to appeal to the Deputy Secretary the decision of the Executive Manager. Stakeholders must give reasons for their appeal. Appeals can be sent to the following address by close of business on **Friday 24 May 2002**:

The Deputy Secretary will take into account the following matters in making a determination on any appeal:

- . whether the scope of the IRA is reasonable (with regard to the proposal or application, and any current related work) and is an efficient use of public resources;
- . whether the timetable will allow adequate opportunity for stakeholder input;
- . whether the nominated IRA team membership will provide appropriate expertise to consider all relevant scientific issues; and
- . any other matter that the Deputy Secretary may think is relevant.

Respondents are advised that, subject to the *Freedom of Information Act 1982* and the *Privacy Act 1988*, all submissions received in response to Plant Biosecurity Policy Memoranda will be publicly available and may be listed or referred to in any papers or reports prepared on the subject matter of the Memoranda.
