IMPORT RISK ANALYSIS – UNSHU MANDARINS FROM

JAPAN

2002/49

The purpose of this Plant Biosecurity Policy Memorandum (PBPM) is to notify you of the availability of a technical issues paper for the import risk analysis (IRA) on fresh unshu mandarin fruit from Japan.

PBPM 2002/16 of 23 April 2002 advised stakeholders of the Executive Manager's decision on the proposed scope, indicative timetable and approach for the IRA on fresh unshu mandarin fruit from Japan. Stakeholders had until 24 May 2002 to appeal the decision to the Deputy Secretary of AFFA. No appeals were received.

A technical issues paper has been prepared for this IRA. The purpose of the technical issue paper is to provide information on the:

biosecurity framework

- method for pest risk analysis
- proposal to import fresh Unshu manadrain fruit from Japan
- preliminary results of pest categorisation and
- further steps in the IRA process.
