## PLANT BIOSECURITY POLICY MEMORANDUM 2003/07

## IMPORT RISK ANALYSIS – MANGOSTEEN FROM THAILAND

The purpose of this Plant Biosecurity Policy Memorandum (PBPM) is to notify you of the availability of a technical issues paper for the import risk analysis (IRA) on fresh mangosteen fruit from Thailand.

PBPM 2002/36 of 21 August 2002 advised stakeholders of the Action Items from the stakeholder workshops for the IRA on fresh mangosteens from Thailand held in Cairns and Darwin on the 29 and 30 July 2002, respectively. Stakeholders had the opportunity to comment on the Action Items and on other issues they felt should be considered in this IRA.

A technical issues paper has been prepared for this IRA. The purpose of the technical issue paper is to provide information on the:

- biosecurity framework
- · method for pest risk analysis
- · proposal to import fresh mangosteen fruit from Thailand
- · preliminary results of pest categorisation and
- · further steps in the IRA process.
