## PLANT BIOSECURITY POLICY MEMORANDUM 2003/13

## DRAFT IMPORT POLICY FOR NETHERLANDS TRUSS TOMATOES

This Plant Biosecurity Policy Memorandum is to notify stakeholders of the release of draft import conditions for truss tomatoes from the Netherlands.

Plant Biosecurity Policy Memorandum 2003/09 of 24 March 2003 notified stakeholders of Plant Biosecurity's intention to assess the Netherlands' market access request for truss tomatoes by way of an extension of existing policy.

A *draft import policy for truss tomatoes from the Netherlands* has now been developed. The draft import policy is available from the AFFA website at <a href="www.affa.gov.au/plantbiosecurity">www.affa.gov.au/plantbiosecurity</a> or copies can be requested from the contact point below. Comments on the draft import policy should be received by Technical and Administrative Services by 30 June 2003.
