## ANIMAL BIOSECURITY POLICY MEMORANDUM 2004/17 CHANGES TO IMPORT RISK ANALYSIS TEAMS

This Animal Biosecurity Policy Memorandum (ABPM) informs stakeholders that, following the appointment of Dr Banks as acting Executive Manager of Biosecurity Australia, Dr Robyn Martin will replace him as the Chair of the import risk analysis (IRA) teams for prawns and prawn products, egg and egg products, psittacine birds, flamingos and pig semen.

Dr David Banks, previously General Manager of Animal Biosecurity, has been temporarily appointed to the position of Executive Manager of Biosecurity Australia. Dr Robyn Martin, previously Manager of Non-ruminants of Animal Biosecurity, is acting General Manager of Animal Biosecurity.

As a result of this change, Dr Martin will replace Dr Banks as the chair of the IRA teams for prawns and prawn products, eggs and egg products, psittacine birds, flamingos and pig semen. Dr Pat Boland, a Principal Veterinary Officer with Animal Biosecurity will replace Dr Martin as the secretary of the pig semen IRA team. Given the advanced stage of the uncooked chicken meat IRA, Dr Banks will continue as Chair of the IRA team. Below is the membership of the teams:
