PLANT BIOSECURITY POLICY MEMORANDUM 2004/15

REVISED DRAFT IMPORT RISK ANALYSIS REPORT FOR APPLES FROM NEW ZEALAND – INFORMATION SESSIONS

This Plant Biosecurity Policy Memorandum (PBPM) confirms details of eight regional information sessions to assist stakeholders in preparing submissions to the *Revised Draft Import Risk Analysis Report for the Importation of Apples from New Zealand.*
