Thank you for the opportunity to provide comments on the IGAB Review Discussion Paper.

**RESPONSE TO QUESTIONS:** 

Question 1. The ACT believes the IGAB is a suitable mechanism to underpin Australia's national biosecurity system. The priority areas are still appropriate however we believe more emphasis should be put into assisting smaller jurisdictions in addressing gaps in emergency response arrangements.

Question 10. Full participation of PHC and AHC as member of NBC should be considered. Current arrangements suggests a divide between government and industry.
