General information about import permit applications

The Department of Agriculture, Water and the Environment (the department) currently does not charge import permit or assessment fees for goods destined for Australian External Territories.

Upon submission of a completed import permit application form, the department will assign the permit application for assessment. Once the permit application has reached the assessment stage, you will receive a confirmation email from the department along with an import permit application reference number.

At the time of application, you must provide a full list of ingredients together with manufacturing/processing details. Information requested in questionnaires and application forms is essential to allow the department to complete your permit application assessment.

Failure to supply relevant or complete information to satisfy the Director of Biosecurity that the biosecurity risks are able to be managed may result in the application being refused or delays in assessment.

Submission of an import permit application form does not guarantee an import permit will be granted.

Under the *Biosecurity Act 2015* (the Act), the department has a maximum of 123 business days to assess an import permit application and make a decision, noting this time period can be extended where the department undertakes a prescribed activity as described in Section 42 of the Biosecurity Regulations 2016.

Where possible, the department is committed to a service standard of issuing import permits within 20 business days of receiving a completed application. Applications may take longer if:

- incomplete or incorrect information is provided by the applicant
- additional information is required to continue the assessment (applicants will be notified of this by the assessing officers)
- technical advice on a good is required
- import conditions have not previously been developed for this product

Please note, import permit applications for select goods from countries other than Australia will need to be accompanied by a production questionnaire, completed and signed by the manufacturer of the goods <http://www.agriculture.gov.au/import/goods/plant-products/questionnaire>.

A plant based animal feed and fertiliser production questionnaire is required for the following commodities:

- Stockfeed
- Petfood including birdseed
- Fertiliser
- Baits
- Bioremedial products
- Geotextiles

Manufacturers may provide information directly to the department by email to imports@awe.gov.au, however the import permit application reference number must be quoted. Failure to provide a production questionnaire may result in the permit application being deemed as not having been received by the department.

It is a criminal offence pursuant to section 186 of the **Act** to bring or import goods into Australian territory without an import permit where an import permit is required.

The **Act** states that conditionally non-prohibited goods must not be brought or imported into Australian territory unless the specified conditions (including conditions for administrative purposes) are complied with.

The **Act** does not provide for permits to be issued after goods have been imported into Australian territory. Goods arriving without an import permit where a permit is required, including where an application is currently under consideration, will be directed for export from Australian territory or disposed of in an approved manner at the importer's expense.
