## Notification of the Ministry of Agriculture and Cooperatives

# RE: Cooked food made from or contain or cooked from carcass to be considered as 'carcass' according to Animal Epidemics Act, BE 2558 (2015), BE 2018

In this Notification:

'carcass' means a body or part of a body of a dead animal or **anything derived from living or dead animals**, and shall include cooked food comprised of, made or prepared from carcasses, or finished artificial items made from carcasses as prescribed in the Notifications by the Minister according to the Thailand *ANIMAL EPIDEMICS ACT 2015*

"Cooked food" means food which people could eat immediately and includes food which must go through certain steps in order to be edible.

Cooked food made from or contained or cooked from the following carcass shall be considered as 'carcass' according to Section 4 of the Animal Epidemics Act, BE 2558 only for the import, export or transit into the country.

# RE: Cooked food made from or contain or cooked from carcass to be considered as 'carcass' according to Animal Epidemics Act, BE 2558 (2015), BE 2018

It deems appropriate to control the import, export or transit of cooked food contained or cooked from carcass in order to prevent and control epidemics.

By the virtue of 'carcass' definition provided in Section 4 and Section 5 of the Animal Epidemics Act BE 2558, the Minister of Agriculture and Cooperatives issues the following announcements:

\*Note: Based on the Animal Epidemics Act, 'carcass' means a body or part of a body of a dead animal or anything derived from living or dead animals, and shall include cooked food comprised of, made or prepared from carcasses, or finished artificial items made from carcasses as prescribed in the Notifications by the Minister.

1) This Notification shall come into effect after 60 days it is announced in The Royal Gazette.

2) In this Notification

a) "Cooked food" mean food which people could eat immediately and also include food which must go through certain steps in order to be edible.

3) Cooked food made from or contained or cooked from the following carcass shall be considered as 'carcass' according to Section 4 of the Animal Epidemics Act, BE 2558 only for the import, export or transit into the country.
