TASMANIAN COMMUNITY FOREST AGREEMENT RESEARCH INTO ALTERNATIVES TO THE USE OF 1080

TERMS OF REFERENCE

The primary goal of the Technical Panel (TP) is to provide technical support and advice to the Implementation Committee (IC) and provide support to the independent expert and liaise with the Stakeholder Advisory Group (SAG) in identifying, commissioning and reporting on research and demonstration of alternatives to the use of 1080 to control browsing animal damage on private forest and agricultural land.

The panel will meet on a six monthly basis, or as required. Membership is listed in Attachment A.

The Technical panel will be responsible for the ongoing practical implementation of the programme including

- Liaison with the Stakeholder Advisory Group on technical research and/or field trial issues:
- Support the independent expert in preparing the workshop to review and provide a gap analysis of current research into alternatives to 1080;
- Support for and participation in the initial review of research and other technical activities already undertaken and outcomes from these activities;
- Advising on any additional research that may be needed, providing advice and support on contracting for that research and advising on the implications for program timelines;
- Providing recommendations and support on the contracting of extension and demonstration activities as and when required;
- Providing reports on completed research activities and subsequent future research and/or development programs as required by the IC;
- Providing key input to the final program evaluation and report;
- The project manager will be further responsible for providing updates to meetings of the Implementation Committee as required.

Demonstration and Communication

The Technical Panel will identify suitable demonstration sites that can be used to illustrate the practical implementation of research alternatives to the use of 1080.

The Technical Panel will consider ways to promote community understanding and uptake of research alternatives considered to have a practical application.

The Technical Panel will ensure that regular and meaningful input from industry and the general community is considered in the development of alternatives to ensure the final recommendation report is well received.
