# EXECUTIVE SUMMARY

Development of Regional Forest Agreements (RFAs) is the primary mechanism for implementing the National Forest Policy Statement (NFPS). The NFPS was agreed between the Commonwealth and State Governments (Commonwealth 1992). To implement the NFPS the New South Wales (NSW) and Commonwealth Governments signed a Scoping Agreement in 1996.

The Scoping Agreement commits the State and Commonwealth Governments to undertake a series of comprehensive regional assessments (CRAs) of forested areas to create a comprehensive, adequate and representative (CAR) forest reserve system. A significant conservation aim of the NFPS is the development of a CAR reserve system to protect biodiversity, old growth forests and wilderness. It also requires the assessment of values important for identifying places of national estate significance.

The CRAs provide the scientific basis on which the State and Commonwealth Governments will negotiate regional forest agreements for the major forests of NSW. These agreements will determine the future of the State's forests, providing a balance between conservation and ecologically sustainable use of forest resources.

This report details the work undertaken in the assessment of aesthetic values and places in the Eden CRA process. This work was undertaken as part of the cultural heritage assessments within the NSW CRAs. The cultural heritage assessments are based on the Scoping Agreement which requires both Governments to address heritage issues consistent with State and Commonwealth legislation. This includes the identification, assessment and documentation of national estate and State cultural heritage values, to satisfy Commonwealth obligation under the Australian Heritage Commission Act 1975 and State obligations under the NSW Heritage Act 1977 and the National Parks and Wildlife Act 1974.

Forty three of the areas identified were considered to be of national estate and State heritage value. These areas include Newtons Crossing Camping Area, Jingera Rock, Pheasant's Peak and Nethercote Falls. Most of these values are already protected in existing national parks or within working forests by the application of forest management prescriptions or inclusion in Preferred Management Priority (PMP) categories.

All the areas identified in this report are considered to have national estate value. However, aesthetic values are only one of the values that will be used to identify national estate places for listing in the Register of the National Estate. Areas identified as National Estate will remain indicative until they have been considered by the Australian Heritage Commission. The Commission will also consider the extent of protection of the identified values under the RFA.

# 1. INTRODUCTION

Development of Regional Forest Agreements (RFAs) is the primary mechanism for implementing the National Forests Policy Statement (NFPS) agreed between the Commonwealth and State Governments (Commonwealth 1992). In 1996, the NSW and Commonwealth Governments signed a Scoping Agreement to undertake Comprehensive Regional Assessments (CRAs) of NSW forests to achieve RFAs.

Attachment 1 of the Scoping Agreement (Commonwealth 1996) requires CRAs to 'identify, assess and document national estate values, including natural and cultural heritage, to satisfy Commonwealth obligations under the *Australian Heritage Commission Act 1975*.'

The Australian Heritage Commission criteria for the Register of the National Estate provide the basis for the identification of national estate values.

The criterion of relevance to the assessment of aesthetic values is:

#### Criterion E: Its importance in exhibiting particular aesthetic characteristics valued by the community or a cultural group.

E1 Important for a community for aesthetic characteristics held in high esteem or otherwise valued by the community.

The relevant criterion under the State Heritage Act is:

Significant for strong visual, or sensory appeal or cohesion, landmark qualities; creative and/or technical (including architectural excellence) qualities; creative and/or technical (including architectural) excellence. These State and Commonwealth criteria have sufficiently common concepts to enable a joint assessment to be undertaken that will satisfy both sets of legislation.

The project encompassed a desktop data audit, targeted additional data gathering through research, expert and community workshops and limited field survey. Assessment of heritage significance was undertaken according to criteria for aesthetic value for the Register of the National Estate and NSW State Heritage Inventory. For those places above threshold, documentation sufficient for Interim Listing on the Register National Estate or inclusion in the NSW State Heritage Inventory was prepared

The study area was the Eden CRA region, although the focus was on public forested lands. Private land was only considered where data was publicly available as a context for the assessment of aesthetic places and values on public land.

This project was managed by Environment Australia and oversighted by the Cultural Heritage Working Group of the NSW Environment and Heritage Technical Committee.

# 2. METHODS

#### 2.1 BACKGROUND

The approach used for the Eden CRA aesthetic assessment was based on previous forest studies elsewhere and reflects the limitations of method development in this field.

Methods for assessing aesthetic significance are continually being refined, with perhaps no single established method being acknowledged as an objective and satisfactory approach.

A definition of aesthetic value for the East Gippsland and Central Highlands regional assessment projects was developed and endorsed at an expert peer review workshop in Melbourne in 1993. The definition is as follows:

Aesthetic value is the response derived from the experience of the environment or particular natural and cultural attributes within it. This response can be either to visual or non-visual elements and can embrace emotional response, sense of place, sound, smell and any other factors having a strong impact on human thoughts, feelings and attitudes.

This definition was used as a basis for developing indicators for assessing significance which were applied in the forest studies in the Victorian CRAs.

Stage 1 of this project consisted of an Expert Workshop which reviewed data sources and methods used in the forest assessments elsewhere and established a preliminary method for the NSW CRAs (see Appendix 1: Expert Workshop Agenda and list of participants).

At the Expert Workshop, there was broad agreement that the definition of aesthetic significance called for a wide range of community and expert data sources to be used in heritage assessments. These sources include art and literature, tourism information, applied landscape research, community perception studies and information held by land and natural resource managers. Past studies have also shown that local communities are a rich source of information. Preliminary discussion of approaches to establishing thresholds for the identification and assessment of heritage significance identified this as an area where more work was required.

It was agreed that the method developed for NSW CRAs will need to encompass the aesthetic qualities of all forested lands. Participants recognised that this would be difficult given the limited budget and extensive area to be covered. It was agreed that further work would be required in the future and that CRA assessments would give preliminary results for setting priorities for land allocation and management decisions.

#### 2.2 METHOD

A method for the Eden CRA was developed as follows:

- Existing information on places of aesthetic significance was collated, building on the sources identified in the *Statewide Cultural Heritage Data Audit (non-Indigenous) project* NA 02/EH
- Major gaps in data or in site type represented were identified and filled through a limited collection of art, literature and tourism sources
- Analysis of data gathered in the Community Heritage Workshops held at 7 locations within the Eden CRA Region
- Data from all sources was combined and sifted to yield places of aesthetic value using the indictors listed in Table 3
- Interviews held to draw on knowledge of agency field staff, identifying gaps and delineating and mapping boundaries of aesthetic areas identified through other sources
- Threshold setting and areas identifed validated by Cultural Heritage Working Group
- Assessments finalised and GIS layer produced for Integration and Options development process

 Assessments documented and information entered into NSW CRA Inventory database

#### 2.3 DATA GATHERING

The following data sources were used in this assessment:

Current places entered in the Register of the National Estate or NSW State Heritage Inventory. (Within the Eden CRA Region, only Green Cape lighthouse is curently entered in the Register of the National Estate as significant for aethetic values - though a number of other places have aesthetic attributes noted in the listing information).

- Review of potentially significant aesthetic places and values identified and documented at the 7 Eden CRA Region Community Heritage Workshops (see Appendix 2)
- Published sources including tourism, art and literature sources
- Documents held by NSW SF and NPWS including EIS reports, maps, PMP data

#### 2.4 DATA QUALITY:

#### Art, literature and tourism sources

Data sources were evaluated and sorted into the following groupings:

- Published texts containing qualitative information about particular aesthetic features; photographs and drawings from recognised published sources; good quality travel maps, commentaries, photographs, paintings or drawings. These qualitative sources were analysed and included in the data compilation.
- Ephemeral material, promotional items which are prolifically re-produced, generalised tourism material these sources often do not represent aesthetic qualities in a definitive or specific way, and therefore were excluded as sources.

#### Community Heritage Workshop data

Data gathered at the Workshops relating to aesthetic values was analysed and included in the data compilation.

#### 2.5 VERIFICATION AND ANALYSIS

The assessment method was based on cross referencing data from a range of expert and community sources.

Gaps in data or place types were identified and filled through interviews with NSW SF and NPWS field staff. Eight additional places were identified by agency staff as areas of consistently high public usage and regard (see Table 2). Agency staff were also able to help delineate and map appropriate boundaries for aesthetic values identified from the range of data sources.

Related areas or features in close proximity were amalgamated and treated as a single place. These include, for example, Bounda Lagoon / Beach and Bondi Lake; and Mumbulla Mtn, Picnic Ground and Falls.

Some places were not followed up because there was insufficient data on which to base an assessment of significance. These included Jane Spiers Beach in Nadgee Nature Reserve, Nalbaugh Falls in Nalbaugh State Forests, Wonboyn in Wonboyn State Forest and Pambula River Picnic Ground in Yurammie State Forest.

#### 2.6 SETTING THRESHOLDS FOR HERITAGE SIGNIFICANCE

Data from all sources was combined, and places identified from multiple data sources highlighted as potentially significant. Thresholds were set on the basis of the indicators contained in Table 3. A total of 146 identified areas was refined to yield a list of 43 places above threshold. The following rulesets were used:

- places that were nominated through one community heritage workshop at a medium level were supported by other sources
- tourism and literature sources were evaluated for use as supporting sources. Identification of the place in literature sources alone was insufficient to nominate a site to the list
- no expert field study was undertaken in the Eden region in accordance with threshold indicator 5.

The Cultural Heritage Working Group reviewed and confirmed the final list of places that were recommended as above threshold for heritage listing.

# 3. RESULTS

Forty three aesthetic areas of national estate and State heritage significance were identified. These ranged from forest lookouts such as Myrtle Mountain Lookout, to scenic touring routes through the forest, such as Wog Way Forest Drive, to waterfalls and picnic spots.

Delineated areas of aesthetic value are listed in Table 4 and shown on the accompanying map, (Map 1).

Twenty two of the aesthetic areas identified are on NSW State Forest and of these eleven are currently managed under the Preferred Management Priority System (see Table 4).

#### Preferred Management Priority (PMP) System

The PMP system has been implemented on State Forests in NSW since 1980. The system is a mapbased system of area classification which indicates management intent within State Forests. Areas are identified as having particular values and appropriate management prescriptions are applied to maintain or enhance such values. The PMP maps (available for most areas on GIS at 1:25 000 scale) together with Management Plans, are strategic plans for State Forests Management Areas. The strategies are refined further in detailed operational plans, including harvesting plans, hazard reduction burning plans, roading and recreational plans and plans for the management of Flora Reserves.

The PMP system is a three tiered system. The first level categorises forest into indigenous, exotic or non-forestry use. The second level under the indigenous heading has categories of multiple use native forest; undeveloped native forest; preserved native forest and native species plantation. The third level incorporates the special emphasis categories for management, which include categories of relevance to aesthetic values. These include:

- recreation areas which have natural features of special significance to forest recreation;
- education areas which have special natural or cultural features, which demonstrate forest values and forestry practices or promote environmental awareness;
- visual resource protection areas of particular visual sensitivity such as areas of vegetation along roadsides, escarpments or hillsides, which form noticeable landscape components and require special consideration to maintain visual quality;
- flora and/or fauna protection areas containing habitats of flora or fauna of special significance and areas reserved for general habitat protection, where the preservation of an area as preserved native forest (2nd level PMP) is not warranted or is under consideration;
- historical values areas containing structures, ruins or artefacts of significance to the history of exploration or settlement of Australia;
- Aboriginal sites areas of established significance to Aboriginal history or culture.

Management of the special emphasis categories aims to protect or maintain the values identified. Special emphasis categories are applied to any areas where special values are known to exist and where such values need to be formally recognised.



# 4. CONCLUSIONS

This report presents the outcomes of the national estate and state heritage assessment of aesthetic areas in the Eden CRA. This assessment contributes to meeting the Scoping Agreement requirements in relation to the National Estate and contribute s to the development of options for a CAR reserve system and RFA for Eden.

The results of the assessment show that the majority of the expressions of the value are already protected in existing national parks or by off reserve management such as inclusion in PMPs.

All the areas identified are considered to have national estate value. However, aesthetic value is only one of the values that will be used to identify national estate places for listing in the Register of the National Estate.

These area will also be included in the NSW State Heritage Inventory database and may be relevant for inclusion on Section 170 registers maintained by State agencies to meet statutory requirements under the NSW Heritage Act.

#### **Summary Outcomes**

At the Expert Workshop, there was broad agreement that:

- The definition of aesthetic significance called for a wide range of community and expert data sources to be used in heritage assessments. These sources include art and literature, tourism information, applied landscape research, community perception studies and information held by land and natural resource managers.
- Past studies have also shown that local communities are a rich source of information.
- Preliminary discussion of approaches to establishing thresholds for the identification and assessment of heritage significance identified this as an area where more work was required.
- It was agreed that the method developed for NSW CRAs will need to encompass the aesthetic qualities of all forested lands.

- Participants recognised that this would be difficult given the limited budget and extensive area to be covered.
- It was agreed that further work would be required in the future and that CRA assessments would give preliminary results for setting priorities for land allocation and management decisions.

# APPENDIX 4

#### AUSTRALIAN HERITAGE COMMISSION CRITERIA FOR THE REGISTER OF THE NATIONAL ESTATE

Without limiting the generality of sub-section (1) of the *Australian Heritage Commission Act 1975*, a place that is a component of the natural or cultural environment of Australia is to be taken to be a place included in the national estate if it has significance or other special value for future generations as well as for the present community because of:

#### Criterion A: Its importance in the course, or pattern, of Australia's natural or cultural history.

A.1 Importance in the evolution of Australian flora, fauna, landscapes or climate.

A.2 Importance in maintaining existing processes or natural systems at the regional or national scale.

A.3 Importance in exhibiting unusual richness or diversity of flora, fauna, landscapes or cultural features.

A.4 Importance for association with events, developments or cultural phases which have had a significant role in the human occupation and evolution of the nation, State, region or community.

### Criterion B: Its possession of uncommon, rare or endangered aspects of Australia's natural or cultural history.

B.1 Importance for rare, endangered or uncommon flora, fauna, communities, ecosystems, natural landscapes or phenomena, or as a wilderness. B.2 Importance in demonstrating a distinctive way of life, custom, process, land-use, function or design no longer practiced, in danger of being lost, or of exceptional interest.

#### Criterion C: Its potential to yield information that will contribute to an understanding of Australia's natural or cultural history.

C.1 Importance for information contributing to a wider understanding of Australian natural history, by virtue of its use as a research site, teaching site, type locality, reference or benchmark site.

C.2 Importance for information contributing to a wider understanding of the history of human occupation of Australia.

#### Criterion D: Its importance in demonstrating the principal characteristics of: (i) a class of Australia's natural or cultural places; or (ii) a class of Australia's natural or cultural environments.

D.1 Importance in demonstrating the principal characteristics of the range of landscapes, environments or ecosystems, the attributes of which identify them as being characteristic of their class.

D.2 Importance in demonstrating the principal characteristics of the range of human activities in the Australian environment (including way of life, custom, process, land-use, function, design or technique).

## Criterion E: Its importance in exhibiting particular aesthetic characteristics valued by a community or cultural group.

E.1 Importance for a community for aesthetic characteristics held in high esteem or otherwise valued by the community.

#### Criterion F: Its importance in demonstrating a high degree of creative or technical achievement at a particular period.

F.1 Importance for its technical, creative, design or artistic excellence, innovation or achievement.

### Criterion G: Its strong or special associations with a particular community

### or cultural group for social, cultural or spiritual reasons.

G.1 Importance as a place highly valued by a community for reasons of religious, spiritual, symbolic, cultural, educational, or social associations.

#### Criterion H: Its special association with the life or works of a person, or group of persons, of importance in Australia's natural or cultural history.

H.1 Importance for close associations with individuals whose activities have been significant within the history of the nation, State or region.

#### Completed Assessments Documented for the CRA Inventory Database
