#### WESTERN AUSTRALIAN REGIONAL FOREST AGREEMENT

#### JUNE 2000 ANNUAL REPORT

The Regional Forest Agreement for the south-west forest region of Western Australia was signed by Premier Richard Court and Prime Minister John Howard on May 4 1999.

Attachment 3 of the Regional Forest Agreement establishes milestones that are to be achieved by both governments during the twenty-year life of the Agreement. This report outlines both Commonwealth and State Government obligations under clause 34 of the Regional Forest Agreement for the south-west forest region of Western Australia, whereby the parties to the Agreement are to report annually on the milestones. Only those milestones that are due for completion by June 2000 are reported in detail, although information on significant progress towards future milestones is also provided.

Clause 39 of the Regional Forest Agreement requires the Commonwealth to table in the Commonwealth Parliament the annual reports detailing achievement of the milestones for the first four years of the Agreement.

Following the signing of the Regional Forest Agreement (RFA) in May 1999, a number of developments occurred. In July 1999, the Western Australian Government announced a series of changes to the management of native forest in the south-west. This new course in forest management includes encouraging greater community involvement in decisions about forest management, together with an accelerated program to restructure the timber industry.

Following a report by the Western Australian Ministerial Advisory Group in December 1999, the Western Australian Government announced its commitment to implementing this new forest policy.

The process of developing these changes to Western Australian Government forest policy has involved the commitment of considerable resources that would otherwise have contributed to implementing the commitments in the RFA. Consequently, some of the commitments by Western Australia in the RFA will now take a little longer to put in place.

The topic of "The Sustainability of Current Fire Management Regimes in WA Forests" was discussed at a public forum of the Colloquium on Forest Management hosted by the Scientists for Sustainability in April 2000. This was followed by a field trip involving interested members of the public. CALM has published and distributed 10,000 copies of a special issue of <i>Landscope</i> magazine containing articles by fire scientists and fire managers, including coverage of the ecological basis of fire management. Internal workshops have been conducted with CALM fire managers to address the planning and operational requirements for the use of fire to meet conservation objectives and protection objectives. Commencing in Spring 2000, all Forest Districts will have available for public access annual burning plans and medium-term Master Burn Plans that integrate the requirements for forest and community protection, conservation of biodiversity, silvicultural treatments and harvesting/regeneration plans. These burn plans will include an outline of the critical fire management requirements, including the ecological basis for fire regimes that were considered and integrated in their development.

The study aimed to develop a WTA that allows fire managers to determine the most appropriate and cost-effective strategies, including prescribed burning, to achieve fire protection and ecological management objectives. The WTA is a decision-support tool that assists managers to quantify the various risks that contribute to the overall risks of wildfire damage and ecological damage to fire vulnerable assets and environmental values. The weightings given to different values were reviewed and modified where appropriate, as a part of this study. It is intended to extend the outcomes of the pilot study to other areas in south- west Western Australia.

Their titles are "Code of Practice for Timber Harvesting in Western Australia" and "Manual of Management Guidelines for Timber Harvesting in Western Australia". The documents have been reviewed, and it was concluded that field operators/staff can understand them. However, consideration is being given to the production of a new, short booklet for the general public/students about timber harvesting in WA.

Whilst the system has been validated on separate data sources, ongoing validation will improve predictability.
